**\*Note:** Acquirer’s and PACs’ direct shareholding/voting rights in Target Company (Omaxe Limited) remained intact before and after the above-mentioned transaction. 4,52,000 Equity Shares of Guild Builders Pvt. Ltd. (Holding Company of Omaxe Limited) are transferred by Mr. Sunil Goel to his brother Mr. Rohtas Goel, by way of Gift on 19.02.2024, which shall be equivalent to 0.57% proportionate percentage of indirect acquisition in Omaxe Limited. The aforementioned transfer is in continuation to 4,58,000 shares of Guild Builders Pvt. Ltd., which were transferred by Mr. Sunil Goel to his brother Mr. Rohtas Goel, by way of gift on 20.01.2024, equivalent to 0.58% proportionate percentage of indirect acquisition in Omaxe Limited. Hence, an aggregate of 9,10,000 shares of Guild Builders Pvt. Ltd. have been transferred by Mr. Sunil Goel to Mr. Rohtas Goel, equivalent to 1.16% proportionate percentage of indirect acquisition in Omaxe Limited. The disclosure regarding the same was also made under regulation 10 (5) of SEBI (SAST) Regulation, 2011 dated 15.01.2024.
