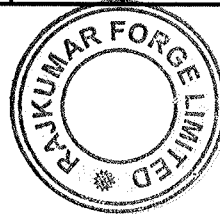

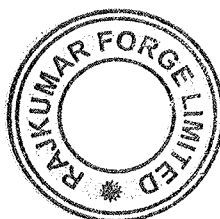



Notes:

- 1) The above Unaudited Financial Results for the quarter and nine months ended December 31, 2020, have been reviewed by the Audit Committee and approved by the Board of Directors at the meeting held on February 06, 2021.
- 2) The Statutory Auditors of the Company have carried out a limited review of the above results.
- 3) The financial results for the quarter and nine months ended December 31, 2020, have been prepared in accordance with the Companies (Indian Accounting Standards) Rules, 2015 (IND AS) prescribed under section 133 of the Companies Act, 2013 and other recognized accounting practices and policies, to the extent applicable and is in compliance with the presentation and disclosure requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulation, 2015 (as amended), including relevant circulars issued by the SEBI from time to time.
- 4) The Company being engaged in Manufacturing of Forgings activities and accordingly there is no separate reportable segment as per IND AS 108 specified under section 133 of the Companies Act, 2013
- 5) On account of the outbreak of COVID 19 virus, the Government of India had imposed a national wide lockdown on March 24, 2020 leading to temporary shutdown of the Companys' manufacturing facilities and operations. Since the later part of May, 2020, the Government had progressively relaxed lockdown conditions and allowed industries and businesses to resume operations and the Company had accordingly commenced its business activities partially after obtaining requisite permissions from appropriate government authorities. In light of such disruption in business activities during the period ended December 31, 2020 the results for nine months period are not comparable to the previous period presented.
- 6) The Indian Parliament has approved the Code on Social Security, 2020 which subsumes the Provident Fund and the Gratuity Act and rules there under. The Ministry of Labour and Employment has also released draft rules thereunder on 13 November 2020 and has invited suggestions from stakeholders which are under active consideration by the Ministry. The Company will evaluate the rules, assess the impact if any, and account for the same once the rules are notified and become effective.
- 7) Figures pertaining to previous period / year have been regrouped / recast / reclassified wherever necessary, to make them comparable

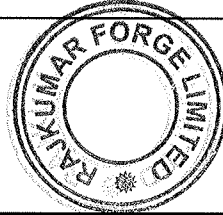
