

New Delhi, **July 1**, **2020**: The COVID-19 Pandemic had led to nationwide lockdown starting 24th March 2020. APL Apollo Tubes Ltd (the company), India's leading branded structural steel tubes company, complied with the directives issued by the Central Government and the respective State Governments to combat the pandemic. The operations and manufacturing activities at all offices and plants had been temporarily closed till the government announced relaxations. The company resumed operations at its plants gradually from 22 April 2020 onwards from Raipur.

The company today announced its sales volume performance for the quarter ending June 30, 2020. It registered sales volume of 238,311 tons in Q1FY21 (61% of Q1FY20 volume and 59% of Q4FY20 volume).
