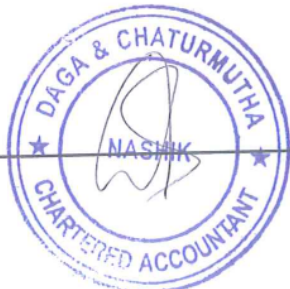

Opinion

We have audited the accompanying annual financial results of **Hindustan Hardy Limited** ("the Company"), for the year ended March 31, 2024 ("the Statement") attached herewith, being submitted by the company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ("the Listing Regulations").

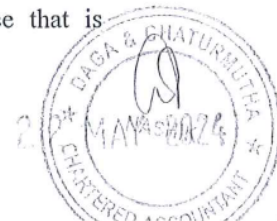
The Board of Directors are responsible for overseeing the Company's financial reporting process.
