In terms of the circulars issued by the Ministry of Corporate Affairs, Government of India (the "MCA") vide its General Circular No.14/2020 dated 8<sup>th</sup> April 2020 and General Circular No.17/2020 dated 13<sup>th</sup> April 2020 (the "MCA Circulars"), in view of the current extraordinary circumstances due to COVID-19 pandemic requiring social distancing, companies are advised to take all decisions requiring members' approval, other than items of ordinary business or business where any person has a right to be heard, through the mechanism of postal ballot / e-voting in accordance with the provisions of the Companies Act

and rules made thereunder, without holding a general meeting that requires physical presence of members at a common venue.

In terms of the MCA Circulars, the Company has, on 18<sup>th</sup> April 2020, completed the despatch of the Postal Ballot Notice by email to all its shareholders who have registered their email addresses with the Company or depository / depository participants and the communication of assent / dissent of the members will only take place through the remote e-voting system. The e-voting facility will be available from 9.00 a.m. (IST) of Sunday, 19<sup>th</sup> April 2020 till 5.00 p.m. of Monday, 18<sup>th</sup> May 2020 (both days inclusive). The hard copy of Postal Ballot Notice along with Postal Ballot Forms and pre-paid business envelope has not been sent to the shareholders for the Postal Ballot in terms of the MCA Circulars.

## Those shareholders who have not yet registered their email address are requested to get their email addresses registered by following the procedure given below:

- a) In light of the MCA Circulars, shareholders who have not registered their email address and in consequence could not receive the e-voting notice may temporarily get their email registered with the Company's Registrar and Share Transfer Agent, Kfintech, by clicking the link: https://karisma.kfintech.com/emailreg and following the registration process as guided thereafter. Post successful registration of the email, the shareholder would get soft copy of the notice and the procedure for e-voting along with the User ID and the Password to enable e-voting for this Postal Ballot. - b) It is clarified that for permanent registration of email address, the shareholders are however requested to register their email address, in respect of electronic holdings with the Depository through the concerned Depository Participants and in respect of physical holdings with the Company's Registrar and Share Transfer Agent, KFin Technologies Private Limited, Selenium, Tower B, Plot 31 & 32, Gachibowli, Financial District, Nanakramguda, Hyderabad-500032, India by following due procedure.
