Sub: Report on Consolidated Results of Remote E-voting and Physical voting through Ballot Papers in respect of businesses set forth in the notice of 39th Annual General Meeting of members of the Munoth Capital Market Limited held on Wednesday, September 29, 2021 at 9.00am at the registered office of the Company.

We, K D N & Associates LLP, Chartered Accountant, have been appointed as a Scrutinizer of Munoth Capital Market Limited ("the Company"), pursuant to Section 108 and 109 of the Companies Act, 2013 read with Rule 20 & 21 of the Companies (Management and Administration) Rules, 2014 as amended from time to time, for the purpose of scrutinizing the remote e-voting and physical voting through ballot papers ("Poll") in respect of businesses set forth in the notice of 38th Annual General Meeting ("AGM") of the Company, in a fair and transparent manner.

- 1. Ordinary Resolution to receive, consider and adopt Audited Financial Statements for the financial year ended March 31, 2021 along with reports of the Board of Director and the auditors thereon.
- 2. Ordinary Resolution to appoint a Director in place of Mr. Siddharth Jain who retires by rotation. Being eligible, he has offered himself for re-appointment as Director of the Company.

- 4. The Shareholders holding Shares as on the "Cut off" date, i.e. Wednesday, September 22, 2021 were entitled to vote through remote e-voting and at the AGM through Physical ballot papers on the businesses mentioned in the Notice of AGM of the Company.
- 5. In terms of the aforesaid Notice, remote e-voting was opened for four days which was commenced on Sunday, September 26, 2021 at 09:00 A.M. and ended on Wednesday, Tuesday28, 2021 at 05:00 P.M. and members of the Company, holding Equity Shares of the Company as on Wednesday, September 22, 2021, were required to cast their votes electronically, conveying their assent or Dissent in respect of the ordinary businesses, through remote e-voting platform provided by NSDL.
- 6. At the venue of Annual General Meeting, the Company has provided the facility of voting at the meeting through physical ballot papers to those Shareholders who were present at the Meeting and had not already voted through remote e-voting platform of NSDL.
- 7. After the conclusion of voting at the Annual General Meeting, I first counted the Vote casted at the meeting through physical ballots papers and thereafter unblocked the votes casted through remote e-voting on Thursday, September 30, 2021around at 3.00 P.M., after the completion of voting at the Annual General Meeting, in presence of two witnesses who are not in employment of the Company.
- 8. I have scrutinized and reviewed the remote e-voting and votes tendered therein based on the data downloaded from the website of NSDL E-voting System and voting through physical ballot paper at the AGM.
