

वसई-विरार शहर महानगरपालिकेची स्थापना झाल्यापासून कोठे बेकायदेशीर बांधकाम, कोठे भूमाफियांचा सडसुळाट, तर कोठे घोट्यांच्या मालिका या सर्व बाबींमुळे वसई-विरार शहर महानगरपालिकेची प्रतिमा पूर्णपणे डागाळली आहे. सध्या नायगाव पूर्व परिसरात भूमाफिया उदंड झाले असून पालिकेच्या निष्क्रिय कारभारामुळे फेरीवाल्यांचा सडसुळाट याटिकाणी वाढला आहे. फेरीवाल्यांना अटीव्यात आणण्यासाठी अतिरिक्त विभाग पथक पालिका प्रशासन केवळ शोभेचे बाहुले म्हणून शिल्लक राहिले आहे का? असा सवाल उपस्थित होऊ लागला आहे.

सध्यास्थित नायगाव पूर्व रेल्वे स्थानक परिसर, पेरा नगर, नायगाव पूर्व ते बापाणे मुख्य रस्त्यालागत फेरीवाल्यांनी जागा दिसेल तिथे वस्तान मांडले आहे. सदरच्या फेरीवाल्यांना राजकीय मंडळी आणि पालिकेतीलच ठेकेदार, कर्मचारी आश्रय देत असल्याचा आरोप होऊ लागला आहे. फेरीवाल्यांना कोणताही अडथळा न पोहोचू देता त्यांच्याकडून अर्धपूण वसुली करण्याचे काम जोमाने सुरू आहे. दोन दिवसांपूर्वी वालीव येथील फेरीवाल्यांनी पालिकाकर्मचाऱ्यांकडून होत असलेल्या अनधिकृत वसुलीबाबत वालीव विभागाय कार्यालयवर मोर्चा काढला होता.

त्यानंतर अनधिकृत वसुलीबाबत ठेकेदार आणि कर्मचारी यांचा भ्रष्ट चेहरा समोर आला आहे. नायगाव पूर्वतील वरील परिसरात फेरीवाल्यांचा वाढलेला सडसुळाट लक्षात घेता ठेकेदार, कर्मचारी आणि काही राजकीय मंडळी आपआपले उखळ पांढरे करू लागले आहेत. उखळ माथ्याने होणारा भ्रष्ट कारभार पाहता फेरीवाल्यांचीदेखील मुजोरी वाढली आहे. येणाऱ्या-जाणाऱ्यांचा नागरिकांना पालिकेचा अतिरिक्त विभाग पथक कोणतीही भुमिका घेताना दिसून येत नाही. ठेकेदार व कर्मचाऱ्यांच्या आर्थिक वसुलीमुळे फेरीवाले उदंड झाले आहेत.
