Dear Sir/Madam,

With reference to your email dated 06<sup>th</sup> February, 2023 and our email reply dated 11<sup>th</sup> February, 2023 followed by your email dated 10<sup>th</sup> March, 2023, we would like to again submit as under:

Shri Tilak Raj Kakkar was appointed on the Board of the Company as Independent Director on 12<sup>th</sup> November, 2014, subsequently based on recommendation of Nomination and Remuneration Committee, the Board of Directors in their meeting held on 05<sup>th</sup> August, 2017 and shareholder at the 20<sup>th</sup> Annual General Meeting held on 23<sup>rd</sup> September, 2017, reappointed Shri Tilak Kakkar as an Independent Director for second term of five consecutive years with effect from 12<sup>th</sup> November, 2017 to 11<sup>th</sup> November, 2022.

Requisite disclosure(s) with reference to appointment and term of Shri Tilak Kakkar were made to the Stock Exchange from time to time. Moreover, information viz. date of appointment and term of appointment etc., were disclosed in all Quarterly Corporate Governance Report [QCGR] including that of September, 2022. His date of cessation (completion of the term of appointment) was informed in QCGR for December, 2022.
