The Chairman then informed the members the proxy register and other register and documents will be available for inspection of members.

With the permission of the members present. Chairman, took the notice of the meeting along with the Audited Standalone Financial Statement of the Company for the Financial Year ending 31st March 2023 did not have any qualifications, observations, comments or any other remarks

Further the Chairman then informed the members that pursuant to the provision of section 108 of the Companies A'ct 2013 read with rule 20 of the Companies (Managemebnt and Administration Rules 2014 and Securities and Exchange Board of India (LODR) 2015 the Company had provided the remote e voting facility to the members of the company whose name appears in the Register of Members as on the cut off date 08/09/2023 to cast their votes electronically in respect of the business to be transacted at the AGM for which the remote e voting period had commenced at 12/09/2023 at 9.30 a.m.and E vote ending time on 14/09/2023 at 5 p.m.

The members were also informed that the facility for voting by way of ballot papers were made available at the AGM venue for the members who had not cast their vote through remote e voting. It was clarified that only those members holding shares of the company as on cut off date i.e 08/09/2023 were eligible to participate in the remote e voting as well as voting at the meeting.

- d. To appoint a Director in place of Mr Madan Gopal Maheshwari who retires by rotation and being eligible offer himself for reappointment

The Chairman of the Annual General Meeting informed that the Board of Directors had appointed Mr Suprabhat Chakraborty, practicing Company Secretary as the Scrutinizer for the purpose of scrutinising the voting process for the resolutions included in the 36th Annual General Meeting
