KDMC announces reservation list of upcoming municipal elections



Kalyan, P.V.Anandpadmanabhan : As per the order of State Election Commission for the forthcoming elections of Kalyan Dombivli Municipal Corporation, the reservation was passed on Tuesday 31st May under the chairmanship of Municipal Commissioner Dr. Vijay Suryavanshi at Acharya Atre Rangmandir. Kalyan Municipal Corporation will hold its next five-year general election and it was announced on Tuesday that the reservation will be released. This election will be held for the first time in a panel system. For the election of 133 members, 3 members, 43 panels, 4 members, 1 panel will be elected from 44 panels for 133 seats. As 13 wards were reserved for Scheduled Castes and 4 for Scheduled Tribes out of 133 seats on Tuesday, out of which 7 seats were reserved for Scheduled Caste women and 2 for Scheduled Tribes, 9 seats were reserved for 50 seats out of remaining 116 seats. Draw lots were drawn through school children of Shri Gajanan Vidyalaya. Although the election will be held on a panel basis, 3 members will be selected from each panel. The former corporator has been hit as the ward name has no authority as the ward structure has been formed for the selection of members from reserved class, women's class and open class. Panel members will be able to stand from any area. Political parties will benefit from this and smaller parties and independent aspiring candidates will be fielded. Ward No. 5, 6, 19, 21 have been reserved for Scheduled Tribes. Wards 2, 4, 6, 7, 15, 17, 19, 20, 22, 23, 25 43 and 44 have been reserved for Scheduled Castes for a total of 13 wards out of which 4 (a), 6 (a), 7 (a) 17 (a), 20 (a), 23 (a) and 43 (a) were declared by drawing seven seats for Scheduled Women. A total of 58 seats were reserved for all ordinary women and these 58 seats were drawn. Ward No. 1 (a), 2 (b), 3 (a, b), 4 (b), 5 (b), 7 (b), 8 (a, b), 9 (a), 10 (a), B), 11 (a, b), 12 (a), 13 (a, b), 14 (a), 15 (b), 16 (a), 17 (b), 18 (a), 20 (B), 21 (b), 22 (b), 23 (b), 24 (a, b), 25 (b), 26 (a), 27 (a, b), 28 (a, b), 29 (A), 30 (a, b), 31 (a), 32 (a, b), 33 (a), 34 (a, b), 35 (a, b), 36 (a, b), 37 (A), 38 (a), 39 (a, b), 40 (a), 41 (a, b), 42 (a), 43 (b), 44 (b, d). The draw of 67 wards has paved the way for elections and since the draw, the formation of aspirants' front has started. Division formation confusion Since the election will be held in a 3 member panel system, the names of the wards have no meaning as 3 members are to be elected in one panel. The formation of a panel of three wards has created a political dilemma for the winning corporators in the last elections. The three candidates have a headache as to which seat to get elected from and which party to field. The panel system has benefited the political party while the smaller parties and independent candidates have suffered. Since a ward wants to elect 3 members, the ruling and opposition parties will field 3 candidates from their own party, making it difficult for independents and smaller parties to find 3 candidates.

Thane : To ensure reservation for Scheduled Castes (Women), Scheduled Tribes (Women) and General Women for the Thane Municipal Corporation General Election to be held in the year 2022, Dr. Administrator and Municipal Commissioner Dr. Kashinath Ghanekar Natyagriha. The reservation was announced on Tuesday under the chairmanship of Vipin Sharma. Out of these, reservation was announced for 5 Scheduled Castes, 2

Scheduled Tribes and 17 General Women seats by drawing lots. According to the census for the Thane Municipal Corporation General Election 2022, the total population is 1,84,14,888, of which the population of Scheduled Castes is 1,26,003 and that of Scheduled Tribes is 42,698. For this election, a total of 46 wards with three member wards and a total of 47 wards with 1 member for four members have been published in the final ward composition. The total number of members for this election is

142, out of which 10 seats for Scheduled Castes, 3 seats for Scheduled Tribes and 129 general seats have been fixed. Out of these 142 seats, 71 seats are reserved for women as per 50% reservation for women. 5 out of 10 seats in the Scheduled Caste category will be reserved for women and 2 out of 3 seats reserved for Scheduled Tribes will be reserved for women. A total of 7 such seats were reserved for women in the reserved group by lottery. For the reserved seats for the remaining 64 women, Hon. The State Election Commission has allotted 47 seats in A and B seats in wards 1 to 47. Out of the remaining 34 seats to be reserved for ordinary

women, 17 seats have been reserved for ordinary women by drawing lots. Ward No. 12A, 23A, 15A, 29A and 3A have been reserved for Scheduled Caste Women. Two seats have been reserved for Scheduled Tribes 5A and 29B and also for 17 general women seats in wards 1B, 2B, 13B, 16B, 18B, 20B, 21B, 25B, 26B, 32B, 36B, 39B, 41B, 43b, 45b, 46b and 47b wards have been fixed.
