I, Rajesh Parekh, Proprietor of M/s. I hereby submit my report as under:

- 1. The Company had completed dispatch on 28th February, 2023, of the Postal Ballot Notice dated 2nd February, 2023 ("Notice") by sending of e-mails to its shareholders whose name(s) appeared on the Register of Members and list of beneficial owners received from National Securities Depository Ltd as on 24th February, 2023 (Cut-off date), for seeking their approval of businesses as per Notice.
- 2. In compliance with the MCA circulars, the Notice were sent only through e-mail to those Shareholders whose email addresses were registered with the Registrar and Transfer Agent/ Depositories as on the Cut-off date with an instruction to cast their votes through e-ting system only as provided by NSDL.
