नई दिल्ली। भारतीय फुटबल टीम के मुख्य कोच इगोर स्टिमक ने गुरुवार को यहां चल रहे राष्ट्रीय शिविर से छह खिलाड़ियों के बैच को रिलीज किया जो एएफसी एशियाई कप टीम का हिस्सा थे। नारायण दास, सलाम रंजन सिंह, धनपाल गणेश, रॉलिन बोर्गेस, कोमल थाटल और चोटिल अनवर अली (जूनियर) को पांच जून से शुरू होने वाले किंग्स कप की तैयारियों के लिए लगे शिविर से रिलीज कर दिया गया।
