Shri Premjit Lal is a Govt. Nominee Director on the MTNL Board. He has joined as Director (Government Nominee) on the Board of MTNL w.e.f. 17.05.2022. He is also a Government Nominee director in BSNL and TCIL. He is also member of Audit Committee in TCIL. Premjit Lal started his career as a technocrat in the telecom/linformation & Communication Technology (ICT)CT sector in Department of Telecommunications (DoT) in early nineties. He worked for more than 22 years in DoT, TEC and leading government telecom service provider - BSNL in the field of planning, design, installation, standardization, operation & maintenance of telecom and data networks. Subsequently, he has worked in public policy and governance in the diverse fields of e-Governance, Information & Communications Technology (ICT), Housing and Urban Development for more than seven years in Ministry of Urban Development (MoUD), Ministry of Housing & Urban Poverty Alleviation (MoHUPA) and ministry of Electronics &IT (MeitY). He was associated with flagship programme of Government of India (Gol)-'Digital India' which envisages creation of empowered society and knowledge-based economy. He has been associated with policy formulation for ambitious plan of providing 'Housing for All' by 2022 in India and formulation of bill on Real Estate Regulation (RERA) which has bough transparency and accountability in this sector. Presently, he is part of IEEE-SA Standards Board (SASB) as GEPS member (Government Engagement Program on Standards). He is presently Vice-Chairman of WG-3 (related to Standardization, Regulation and Policy issues) of APT-WTSA20 of Asia Pacific Tele-community (APT) for devising Resolution for WTSA-2020 for Asia-pacific region. Now, he also represent India in the steering Committee of Open Community for Ethics in Autonomous and Intelligent Systems (OCEANIS) - an autonomous organization for ethical standards in Artificial Intelligence (AI). He has headed secretariat of Asia Pacific Ministerial conference on Housing & Urban Development (APMCHUD) - part of UN-Habitat in 2014-15. He has also been associated with devising of Sustainable Development Goal (SDG) of India as a member of the committee. He has also been part of sub-group in BRICS committee.
