# WPI inflation dips to $3.07 \%$ in April; food prices on therise

New Delhi, May 14
WHOLESALE INFLATION EASED to $3.07 \%$ in April on cheaper fuel and manufactured items, even as prices of food articles remained high, official data released on Tuesday showed. The Wholesale Price Index-based inflation was at $3.18 \%$ in March and 2.93\% in February. It was 3.62\% in April 2018.

Inflationin the'foodarticles' baskethardened to $7.37 \%$ during April 2019 as against 5.68\% inMarch, as prices of vegetables skyrocketed. Food inflation has been on the rise for the last five. months since December 2018 whenit was (-) $0.42 \%$.

Vegetables inflation too has seen a steep rise since December 2018 when it was ()19.29\%. Itstoodat $40.65 \%$ in April, up from 28.13\% in the previous month.

Amongst food items, inflation in potato cooled to ()17.15\%. In case of onion and fruits, it stood at (-) $3.43 \%$ and

THE INCOME TAX department Tuesday deferred for the second time the requirement for companies to include in their tax audit report the details, of goods and services tax (GST) and GAAR

The reporting requirement of these details in income tax audit form has been kept in abeyance till March 31, 2020 - meaning that all income tax audit reports need not include details on GST and General Anti-Avoidance Rules (GAAR)
(-)6.88\%,respectivelyinApril. However, inflation in the fuel and power' category cooled to $3.84 \%$, from $5.41 \%$ in March.

Inflation in diesel halved to $3.24 \%$ during the month from $7.33 \%$ in March. For petrol, inflation was $1.74 \%$ in April, as against 1.78\% in the previous month. However, inflation in LPG spiked to $11.48 \%$ in April, from 0.94\% in the month before.

Theprice of non-subsidised cooking gas (LPG) was increased by ₹ 5 per $14.2-\mathrm{kg}$ cylinder to ₹ 706.50 on Aprill. Non-subsidised LPG is the gas that consumer buys after exhausting their quota of 12 cylinders of $14.2-\mathrm{kg}$ at submarket or subsidised rates. Price of subsidised LPG was almostunchangedat ₹ 495.86 onApril 1.
Manufactured items too saw easing of prices with inflationat 1.72\% in April, against $2.16 \%$ in the previous month.
The Reserve Bank, which mainly factors in retail infla-
tion for its monetary polify, had last month cut intefest rate by 0.25 percentagep $\phi$ ints. The next policy revief in scheduled for June 6.

Assocham deputy secietary General Saurabh Sanyal said, "Both WPI and retail inflation remain benign, well below the 4 per cent target of the RBI, making out a strong case for a rate reduction by the central banknextmonth.

Assocham further said the overall food inflation remains well whthin control and there is an abundant supply of food items. "Lowercost of borrowing is one of the major factors for reviving consumer interest"

According to official data released Monday, retailinflation incheduptoasix-monthhigh of $2.92 \%$ in April due toa spike in food prices, including vegetables and protein rich items.

The RBI has projected retail inflation to remain at 2.9-3\% during April-September, mainly due to lower food and fuel prices as well as expectation of a normal monsoon.

appearance time of $11: 30 \mathrm{am} ;$ official sources said.

While it was not immediately known as to what was the ED's line of questioning on Monday, sources said on Tuesday the two were questioned about their personal and official dealings with the Videocon Group. Their statement was recorded under the Prevention of Money Laundering Act (PMLA) by the investigating officer of the case, they said.

The Kochhars were supposed to depose before the agency earlier this month but they hadthen soughtan extensionoftimewhichwas atpowed.
