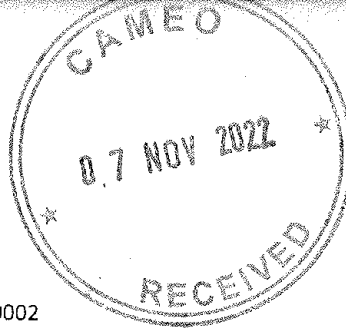


Sir,




