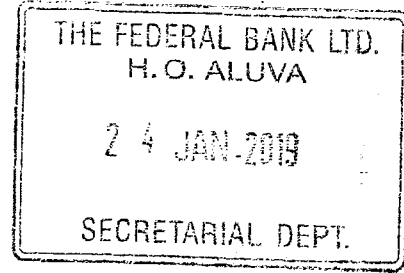

I am holding 4500 shares each of Rs 2/- of Federal Bank Ltd with details as shown above. I lost the original of the said certificate irrecoverably during shifting of my residence from the recorded address at Edappally, Ernakulam to Thrissur. I could not trace the certificate despite repeated sincere efforts. It is a loss from my custody and I do not presume any mischief behind the loss. I approached the local Thrissur East Police Station, in whose jurisdiction my residence falls, with a complaint on loss on 17.10.2018. As per their directions, I inserted a Public Notice in The Malayalam daily Deepika, Thrissur Edition dated 21.10.2018 (Copy with translation enclosed) regarding the loss. After making local Investigations and enquiries, the Police Authorities issued a Certificate of loss dated 24.11.2018(Copy enclosed)

I request you to take steps to issue me a duplicate certificate at the earliest. As I am running 89 years of age, I wish to make use of the investment during my life time itself. Therefore, I request you to take the matter most expeditiously.

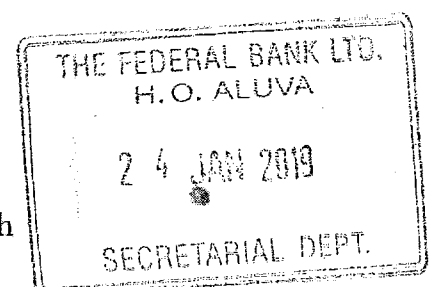

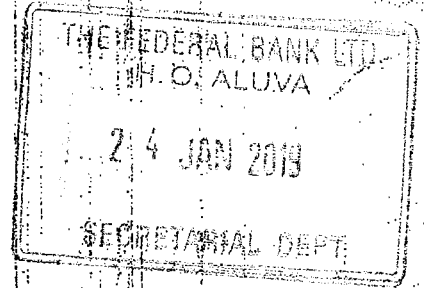

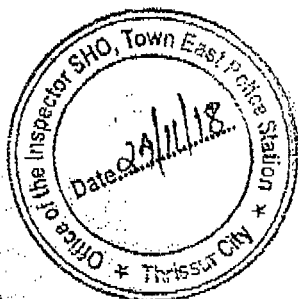




CERTIFICATE

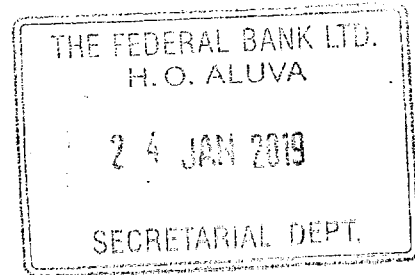


