Sub: Allotment of equity shares of Commercial Engineers & Body Builders Co Limited now name has been changed to (Jupiter Wagons Limited) ("Transferee Company") to the eligible shareholders of Jupiter Wagons Limited ("Transferor Company") pursuant to effectiveness of the Scheme of Amalgamation of Transferor Company into and with Transferee Company under Sections 230 to 232 of the Companies Act, 2013 (including the Companies (Compromises, Arrangements and Amalgamations) Rules, 2016) and other relevant provisions under applicable law ("Scheme")

This is in continuation to our letter dated 18 May, 2022, wherein we had informed that the Scheme had become effective pursuant to filing of the orders of the Hon'ble National Company Law Tribunal, Kolkata Bench and the Hon'ble National Company Law Tribunal, Indore Bench with jurisdictional Registrar of Companies in the prescribed e-form INC-28 pursuant to which the Transferor Company dissolved without winding up. We had also informed that in accordance with the Scheme of amalgamation, Transferee Company will issue and allot to those shareholders whose names would appear as a member in the records of the depositories/register of members of Transferor Company, as the case may be, on the Record Date i.e. 28 May 2022, 5510 (five thousand five hundred and ten) fully paid-up equity shares of Rs. 10 each of Transferee Company for every 100 (one hundred) fully paid-up equity shares of Rs. 10 each, held by such member in Transferor Company. As informed earlier vide disclosure dated 26 May 2022, name of the Transferee Company changed from "Commercial Engineers & Body Builders Co Limited" to "Jupiter Wagons Limited" w.e.f. 25 May, 2022. The process of change of name in the records of the stock exchange is underway.

Accordingly, the Board of Director of Transferee Company, today, i.e. 29 May, 2022, has inter-alia, considered and approved the allotment of 33,86,31,597 equity shares of Rs. 10 each of the company fully
