With regards to the above captioned subject, we would like to inform that Company has duly complied with the Regulation 30 of SEBI (LODR) Regulation, 2015 and all the applicable provisions under Securities and Exchange Board of India (Substantial Acquisition of Shares and Takeovers) Regulations, 2011 ("SEBI SAST") and has intimated to the exchange all the events, information etc that have a bearing on the operation/performance of the company which include all price sensitive information also.

For the purpose of quick reference, all events which took place in the Company from the start of April, 2022 till 31st December, 2022 and their corresponding filings done with exchange along with acknowledgement date are detailed in *Annexure-1*.

According to us, pursuant to the disclosure of the event of Share Purchase Agreement dated July 19, 2022 ("SPA") between the Acquirers and the Promoter and Promoter group entities/Sellers and subsequent Public Announcement of Open Offer for acquisition of 1,66,400 fully paid up Equity Shares representing 26.00% of the paid up and voting Equity Share Capital of face value ₹ 10/-(Rupees Ten Only) each at a price of ₹ 659/- on July 19, 2022 triggered the price movement.

We would further like to inform that pursuant SPA and as disclosed in Letter Of Offer dated 21st September, 2022, Sellers and Acquirers had opened an Escrow Demat Account with the Share Escrow Agent pursuant to which the Sellers have on 27th July, 2022, deposited 3,49,373 Equity shares (Sale Shares) with the Share Escrow Agent. It is thereby implied that the volumes of transaction that took place in the script since 27th July, 2022 were done by the shareholders of the Company under the category "Public Shareholders".
