Summary Proceedings of the 47th Annual General Meeting of Steel Authority of India Limited (SAIL) held on 30th August, 2019

The 47th Annual General Meeting (AGM) of the Members of Steel Authority of India Limited (SAIL) was held at 1030 hours on Friday, the 30th August, 2019 at NDMC Indoor Stadium, Talkatora Garden, New Delhi-110001.

In terms of Article 62 of the Articles of Association of Steel Authority of India Limited, Shri Anil Kumar Chaudhary, Chairman & Managing Director of the Company chaired the AGM. The meeting was properly convened and constituted and requisite quorum was present throughout the meeting. With the consent of the Chairman and Members present, the Notice of the meeting already circulated to the Members was taken as read.

Chairman addressed the Shareholders and outlined the Outlook along with performance of the Company. Supply of steel in the development of the Nation, Marketing/Logistics Initiatives being undertaken by the Company, Corporate Governance, etc. Copy of the Chairman's speech was also circulated to all Members attending the meeting. The Company Secretary read the Statutory Auditors' Report, Secretarial Auditor's Report, Report of Comptroller & Auditor General of India on the Accounts of the Company for the Financial Year 2018-19 and drew attention of the Members to the explanations given by the Board of Directors on the observations/qualifications, etc. of the Statutory Auditors.

The Company Secretary informed the Members that pursuant to Regulation 44 of the SEBI(Listing Obligations and Disclosure Requirements) Regulations, 2015 and Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014, the Company had provided e-voting facility to its Members which commenced on 27th August, 2019 at 0900 Hours (IST) and ended on 29th August, 2019 at 1700 Hours (IST). The Company had engaged the services of M/s. National Securities Depository Limited to provide remote e-voting facility to the Members of the Company.

The Company Secretary stated that the Company had issued the Notice dated 31st July, 2019 containing the following Items for approval of the Members at this AGM and Chairman explained the objectives and implications of the same:

1.	Resolution: I: Ordinary Resolution. To receive, consider and adopt (i) the Audited Standalone Financial Statements of the Company for the Financial Year ended 31 st March, 2019 together with Reports of the Board of Directors and Auditors thereon. (ii) the Audited Consolidated Financial Statements of the Company for the Financial Year ended 31 st March, 2019 and the Report of the Auditors thereon.


2.	Resolution: 2: Ordinary Resolution. To appoint a director in place of Ms. Soma Mondal (DIN:06845389), who retires by rotation at this Annual General Meeting and is eligible for re-appointment.
3.	Resolution: 3: Ordinary Resolution. To appoint a director in place of Shri Atul Srivastava (DIN:07957068), who retires by rotation at this Annual General Meeting and is eligible for re-appointment.
4.	Resolution: 4: Ordinary Resolution. To fix the remuneration of the Auditors of the Company appointed by the Comptroller & Auditor General of India for the Financial Year 2019-20.
5.	Resolution: 5: Ordinary Resolution. To declare Final Dividend for the Financial Year 2018-19 @ Rs.0.50 per Equity Share of face value of Rs.10/- each.
6.	Resolution: 6: Special Resolution. To re-appoint CA Parmod Bindal (DIN: 06389570) as an Independent Director of the Company.
7.	Resolution: 7: Special Resolution. To re-appoint Prof. Ashok Gupta (DIN:07342950) as an Independent Director of the Company.
8.	Resolution: 8: Special Resolution To re-appoint Smt. Anshu Vaish (DIN:02924346) as an Independent Director of the Company.
9.	Resolution: 9: Ordinary Resolution To appoint Shri Krishan Kumar Gupta (DIN:03476812) as an Independent Director of the Company.
10.	Resolution: 10: Ordinary Resolution To appoint Shri Vivek Gupta (DIN:08370793) as a Whole-time Director of the Company.
11.	Resolution: 11: Special Resolution To obtain consent for Borrowings upto Rs.5,000 crore through private placement of Non-Convertible Debentures/Bonds and creation of charge on the assets of the Company.
12.	Resolution: 12: Ordinary Resolution To ratify Remuneration of Cost Auditors of the Company for the Financial Year 2019-20.

Thereafter, the Company Secretary explained the polling process.

The Company Secretary mentioned that the Company has appointed Shri Sachin Agarwal, Practising Company Secretary of M/s. Agarwal S. & Associates, as Scrutinizer, to scrutinize the E-Voting process as well as voting at the AGM, in a fair and transparent manner. As it will take time to compile the votes cast, the results of voting, both E-Voting and Ballot Paper, along with the Scrutiniser's Report will be made available on the website of the Company on or before 1st September, 2019.

It is hereby confirmed that the meeting was convened and conducted as per the provisions of the Companies Act, 2013 and Rules thereunder and Secretarial Standards issued by the ICSI.

The meeting concluded at 1150 Hours.
