राष्ट्रीय चिकित्सा आयोग (एनएमसी) ने एक आश्चर्यजनक एवं प्रतिकूल कदम उठाते हुए नए मेडिकल कॉलेजों

की स्थापना के नियमों में बदलाव की तैयारी शुरू कर दी है। आयोग ने दूरी एवं जनसंख्या के आधार पर मेडिकल कॉलेजों की स्थापना का प्रस्ताव रखा हैं। इससे हितधारक हैरान है और निजी क्षेत्र में संभावित पंजी निवेश पर प्रतिकल प्रभाव पड़ने की आशंका भी जाहिर की जा रही है। एनएमसी द्वारा तैयार किए न्यूनतम मानदंड मसौदे में कहा गया है कि कोई भी नया मेडिकल कॉलेज मौजूदा मेडिकल कॉलेज से 15 किलोमीटर की दूरी के अंदर नहीं खुल सकता है। एक मेडिकल कॉलेज को 15 किलोमीटर के भीतर लगभग 10 लाख की आबाँदी को सेवा प्रदान कॅरनी होगी या फिर इस दूरी को बढ़ाना होगा। भारत जैसी दुनिया की बड़ी आबादी वाले देश में मेडिकल कॉलेजों की भारी कमी है। इसके चलते स्टूडेंट्स को मेडिकल की पढ़ाई करने अन्य देशों में जाना पड़ता है। उन्हें देश में ही मेडिकल एजुकेशन उपलब्ध कराने के लिए बड़ी संख्या में मेडिकल कॉलेज खोलने की जरूरत है। चूंकि सरकार खुद अर्धिक संख्या में मेडिकल कॉलेज नहीं खोल सकती, इसलिए निजी क्षेत्र के निवेशकों को इसके लिए प्रोत्साहित करने की आवश्यकता है। विडंबना यह है कि एनएमसी मेडिकल कॉलेज खोलने की दिशा में रुचि रखने वाले निवेशकों को उल्टे हतोत्साहित कर रही है। राज्य सरकारें स्वास्थ्य, शिक्षा, पशु चिकित्सा सेवाओं और अन्य ग्रामीण सामुदायिक विकास पहल जैसे प्राथमिक एवं माध्यमिक क्षेत्रों में स्थानिक और जनसंख्या मानदंड लाग कर रही है। विशेषकर स्वास्थ्य और शिक्षा के क्षेत्र में मिले जुले परिणाम मिले है, जबकि ग्रामीण परिदृश्य में भौतिक बुनियादी ढांचे के विस्तार के बावजूद स्टाफ् की भारी कमी है। यहां तक कि प्राथमिक और माध्यमिक स्तर पर भी शिक्षकों व डॉक्टरों की कमी हैं। किसी भी सेक्टर में तृतीयक स्तर की सुविधाएं स्थापित करने के लिए दूरी और जनसंख्या मानदंड लागू नहीं किए गए है, जबकि उच्चतम स्तर पर एक नया विश्वविदयालय, इंजीनियरिंग कॉलेज या मेडिकल अस्पेताल बिना किसी बाधा के स्थापित हो सकता है। यह विरोधाभास है कि एक मेडिकल कॉलेज को इन मानदंडों के अधीन किया जा रहा है। यह कदम हैरान करने वाला है। यही कारण है कि हर तरफ से इसके विरोध में आवाज उठ रही है। सुत्रों का कहना है कि इससे इस क्षेत्र में निजी निवेशकों द्वारा किए जाने वाले पूंजी निवेश पर प्रतिकुल प्रभाव पड़ेगा। इस कदम को मौजूदा मेडिकल कॉलेजों के पक्ष में भी बताया जा रहा है। इससे मौजूदा मेडिकल कॉलेजों के साथ मिलीभगत की आशंका भी जताई जा रही है। वे यह नहीं चाहते कि उनके आसपास कोई दूसरा मेडिकल कॉलेज स्थापित हो, जो उन्हें प्रतिस्पर्धा दे सके। इससे उस क्षेत्र में उनका एकांधिकार बना रहेगा और उन्हें गुणवत्ता मानकों का पालन न करने और मनमाना फीस लेने की खुली छूट मिल जाएगी। अन्य मेडिकल कॉलेजों के साथ प्रतिस्पर्धा न होने से स्वाभाविक रूप से गुणवत्ता पर प्रतिकूल प्रभाव पड़ेगा। विशेषज्ञों का कहना है कि सरकार भले अपने ऊपर यह प्रतिबंध लगा ले, लेकिन वह यह तय नहीं कर सकती कि निजी निवेश कहां करना होगा, क्योंकि इस बारे में निणन्य प्रमोटरों द्वारा विशेषज्ञों और कर्मचारियों की उपलब्धाता को ध्यान में रखकर किया जाता है। यहां तक कि कई इलाकों में मौजूदा मेडिकल कॉलेजों को भी डॉक्टरों और पैरामेडिकल स्टाफ की उपलब्धता को लेकर चुनौतियों का सामना करेना पड़ता है। अजीब बात है कि एनएमसी ने इस तथ्य को नजरअंदाज कर दिया है कि शहरी क्षेत्रों में सरकारी एजेंसियां ऐसी सुविधाओं के लिए क्षेत्र निर्धारित करती है। इस तरह के प्रतिबंध कस्बों और शहरों के नियोजित विकास को सुनिश्चित करने के प्रयासों को बाधित करते हैं। विशेषज्ञों का कहना है कि नए मेडिकल कॉलेज की स्थापना का मतलब सिर्फ भौतिक बुनियादी ढांचा तैयार करना नही है, बल्कि विशेषज्ञों की उपलब्धाता सुनिश्चित करना भी है। एक मेडिकल कॉलेज का सेवा क्षेत्र उसके निकटवर्ती परिवेश से कही आगे तक जाता है, जो कई राज्यों और यहां तक कि विदेशों से भी छात्रों और डॉक्टरों को आकर्षित करता है। हालांकि केंद्र सरकार जहां भारत को मेडिकल दूरिज्म और शिक्षा के केंद्र के रूप में आगे बढ़ाना चाहती है, वही एनएमसी का यह कदम नए निवेश और नए सेंस्थानों के निर्माण में बाधाएं पैदा करेगा। ऐसे में मेडिकल शिक्षा के लिए विदयाथिन्यों का विदेश जाना जारी रहेगा। यह कदम किस कारण से उठाया गया है, यह स्पष्ट नहीं है। लेकिन इसके परिणामस्वरूप इस फैसले का विरोध करने वाली याचिकाओं की बाढ़ आ गई है। उम्मीद है कि नीति निर्माता इस पर ध्यान देंगे और इस क्षेत्र में नए संस्थान खुल सकेंगे, ताकि डॉक्टरों और पैरामेडिक्स की कमी को दूर किया जा सके। साथ ही चिकित्सा शिक्षा और चिकित्सा देखभाल के लिए देश को एक वैश्विक केंद्र के रूप में स्थापित किया जा सके। एनएमसी को इन केंद्रों पर चिकित्सा मानकों को सुनिश्चित करने पर ध्यान केंद्रित करना चाहिए और स्थानीय स्तर पर लिए जाने वाले फैसलों में हस्तक्षेप से बचना चाहिए। यह काम निवेशकों पर छोड़ देना ही बेहतर है। निजी मेडिकल कॉलेज खोलने में निवेशकों के कम से कम दो ढाई सौ करोड़ रुपये लग जाते है। उन्हें सरकार से कोई और मदद नहीं, बल्कि केवल सहयोग चाहिए होता है। ग्रामीण और अर्द्धशहरी क्षेत्रों के लोगों को विश्वस्तरीय चिकित्सा सुविधा तथा डॉक्टरों एवं पैरामेडिकल स्टाफ को बड़ी संख्या में रोजगार उपलब्ध कराने में निजी मेडिकल कॉलेज खोलने की इच्छाशक्ति रखने वाले निवेशकों को अधिकाधिक प्रोत्साहन देना चाहिए, न कि उनकी राह में रोड़े अटकाने चाहिए।

This collaboration has resulted in the development of four products on the 310cc engine platform-manufactured at the TVS plant in Hosur, Tamil Nadu. The first motorcycle was TVS Apache RR 310 (launched in December 2017), followed by BMW G 310 R and BMWG310GS (July 2018), and BMWG 310 RR (July 2022).

All four have collectively sold 140,000 units in markets, including India, the EU, the US, Latin America, Japan and China. Of these, BMW Motorrad has sold more than 21,000 motorcycles in India and exported over 50,000 motorcycles. KN Radhakrishnan, director

& CEO, TVS Motor Company, said the partnership is a testament to common values of BMW and TVS on innovation, quality, customer delight, engineering prowess and a focus on delivering globally-aspirational products. "These four motorcycles are available in more than 100 countries, and with the expansion of this partnership towards future technologies and sustainable mobility solutions, we are in discussions to expand our manufacturing network beyond India to cater to our growth, which includes the recently-unveiled BMW CE 02,"

Radhakrishnan said.

The CE 02 is an electric twowheeler powered by two split 2 kWh lithium-ion battery packs and has a claimed range of 90 km.Som Kapoor, EY India Automotive, Future of Mobility leader(consulting), and partner, told FE that BMW and TVS have natural synergies. "TVS helped BMW with the 310cc platform which was not easily possible for BMW to build in Europe. Thanks to this tie-up, BMW was able to leverage Indian engineering prowess, to make a bike not just for India, but also for global mar kets where buyers are increasinglylooking for midsize motorcycles," he said. "What TVS got from BMW was global brand value, and what BMW got from

TVS was frugal engineering." Saket Mehra, partner, Grant Thornton, said the auto sector, globally, is going through a major transformation, driven by increasing focus on electrification and alternative fuel technologies, realignment of global supply chains, volatility in raw material procurement, and volume growth due to rising disposable incomes. "With these evolving dynamics, it is important to have the right partner ships and tie-ups in place," he said. On why the TVS-BMW partnership is working so well he added that a key factor is the strategic fit between both the partners. "Two companies entering a partnership must have a strong alignment on partnership objectives, structure and defined roles, and have the clear cost and strategic benefits identified," he said.
