खासगी रुग्णालये अधिग्रहित करणार? : हायकोर्ट

नागपूर , दि. १३, (प्रतिनिधी) : कोरोना रुग्णांच्या उपचारांसाठी रुग्णालयांतील खासगी 60 टक्के बेड अधिग्रहित करीत आपत्ती कायद्यांतील तरतुदी लागू करणार काय, अशी विचारणा मुंबई उच्च न्यायालयाच्या नागपूर खंडपीठाने राज्य सरकारला केली आहे. त्यावर १६ ऑक्टोबरपर्यंत उत्तर सादर करण्याचा आदेश देण्यात आला आहे.

शहरातील खासगी रुग्णालयांनी करोना रुग्णांसाठी राज्य सरकारकडून ८० टक्के बेड आरक्षित करण्याच्या कारवाईला आव्हान दिले आहे. त्यावर न्या. रवी देशपांडे आणि न्या. पुष्पा गनेडीवाला यांच्या खंडपीठासमोर सुनावणी झाली. मागील सुनावणीला हायकोर्टाने 'खासगी रुग्णालयात आर्थिकदृष्ट्या मागास असलेल्या नागरिकांना मोफत उपचार मिळावेत,' अशी अपेक्षा केली होती तसेच महात्मा फुले जनआरोग्य योजनेचा लाभ या रुग्णांना देता येईल काय, अशी विचारणा केली होती.

शहरातील मोजक्याच खासगी रुग्णालयांत सदर योजनेचा लाभ देण्यात येत आहे. तेव्हा न्यायालयाने महापौरांच्या अध्यक्षतेखालील करण्यात आलेल्या समितीला याबाबत आढावा घेण्याचा आदेश दिला होता. समितीने खासगी संपर्क साधला. रुग्णालयांशी परंतु बहुतांश रुग्णालयांनी करोना रुग्णांच्या उपचारांवर होत असलेला खर्च बघता सदर योजना लागू करता येणार नाही, असे नमूद केले तसेच योजना लागू करायची असेल तर किमान एक लाख रुपये राज्य सरकारने जमा करावेत, असेही कळवले.

दरम्यान, विवेका रुग्णालयाच्या वतीने बाजू मांडताना ॲड. कार्तिक शुकुल यांनी आपत्ती व्यवस्थापन हायकोर्टाचे कायद्याकडे रुग्णालयांतील ८० टक्के बेड आरक्षित करीत असताना आपत्ती व्यवस्थापन कायद्याच्या कलम ६५ आणि साथीचा रोग प्रतिबंधक कायद्याच्या कलम २ मधील तरतुदीनुसार ८० टक्के बेड व त्याचे व्यवस्थापन ताब्यात घेतलेले नाही. सदर माहितीची न्यायालयाने गंभीर दखल घेतली.

आपत्ती व्यवस्थापन कायद्यातील कलम ६५ नुसार, रूग्णालयांतील आरक्षित केले असते तर त्या बेडच्या व्यवस्थापनासाठी लागणारे डॉक्टर, पॅरामेडिकल स्टाफ आणि इतर आरोग्य सुविधा या राज्य सरकारच्या अधीन झाल्या असत्या. त्याप्रकारे राज्य सरकारच्याच थेट नियंत्रणात येऊन तिथे रुग्णांना मोफत उपचार करता आले असते तसेच रुग्णालयांना मोबदला देण्याचीही आवश्यकता राहिली

परंतु, कायद्यातील तरतुदींच्या अधीन राहून परिपत्रक काढले नसल्याने ते आता कायद्याच्या कचाट्यात सापडले आहे. तरीही आताही राज्य सरकार खासगी रुग्णालयांतील ८० टक्के बेडचे अधिग्रहण कायद्यातील तरतृदींनुसार करणार काय, असा प्रश्न न्यायालयाने उपस्थित केला आहे. सदर बाब धोरणात्मक निर्णयाच्या चौकटीत असल्याने विभागीय आयुक्त व मनपा आयुक्तांनी त्यावर उत्तर देण्यास नकार दिला. त्यामुळे राज्य सरकारला १६ ऑक्टोबरपर्यंत उत्तर सादर करण्याचा आदेश देण्यात आला आहे.

फुलंब्री, दि. १३, (प्रतिनिधी) : तालुक्यातील गणोरी येथे एका अल्पवयीन मुलीची गावातील चार तरुणांनी महिनाभरापूर्वी छेड काढली. त्यानंतरही वारंवार होणाऱ्या त्रासाला कंटाळून या अल्पवयीन मुलीने शुक्रवारी (नऊ ऑक्टोबर) विषारी औषध पिऊन आत्महत्या करण्याचा प्रयत्न केला. या प्रकरणी फुलंब्री पोलिस ठाण्यात चार जणांविरुद्ध गुन्हा दाखल करून त्यांना अटक करण्यात आली. दरम्यान, न्यायालयासमोर हजर केले असता न्यायालयीन कोठडीत हर्सूल जेलमध्ये रवानगी करण्यात आली. आकाश भादवे, आकाश उबाळे, नवनाथ भादवे, संदीप भादवे (सर्व रा. गणोरी), अशी छेड काढणाऱ्या संशयित आरोपींची नावे आहेत. पोलिसांनी दिलेल्या माहितीनुसार, गणोरी येथील एका अल्पवयीन मुलीची आकाश उबाळे याने महिनाभरापूर्वी छेड काढली होती. मात्र मुलीने हीँ घटना घरी सांगितली नाही. त्यानंतर आकाश उबाळेसह आकाश भादवे, नवनाथ भादवे, संदीप भादवे हे या मुलीला सतत त्रास देत होते. त्याला कंटाळून या मुलीने विषारी औषध प्राशन केले. तिला उपचारार्थ रुग्णालयात दाखल केले असता पोलिसांनी जबाब घेऊन गुन्हा दाखल केला. या चारही आरोपीविरुद्ध कलम ३५४, ३५४ अ, ४५२, ३४ भादंवि सहकलम १२१७ बालकांच्या लैंगिक अपराधापासून संरक्षण अधिनियमानुसार गुन्हा दाखल करण्यात आला आहे.
