

We conducted our review in accordance with the Standard on Review Engagement (SRE) 2410

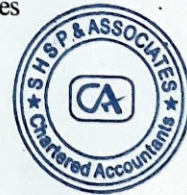
