<sup>&</sup>lt;sup>®</sup> The proviso to Section 68(2)(c) of the Companies Act, 2013, as amended, and explanation to Regulation 4(i) of the Buy Back Regulations state that the Buy Back of Equity Shares in any financial year shall not exceed 25% of the total paid up equity capital of the Company in that financial year. The Company has restricted the Buy Back to a number not exceeding 32,00,000 Equity Shares representing 3.26% of the total paid up equity capital of the Company as on March 31, 2019. The indicative maximum number of Equity Shares to be bought back at the Maximum Buy Back Offer Size and the Maximum Buy Back Offer Price is 24,00,000 Equity Shares, which does not exceed 25% of the total paid up equity capital of the Company.
