**Sub: Intimation under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 regarding Withdrawal/ Cancellation of the deal for Acquisition of 100% shareholding of Mugenesys Software Private Limited ("Mugenesys") by DRC Systems India Limited ("DRC")**

With reference to our earlier intimation dated April 16, 2021 regarding signing of the Term sheet between DRC and Mugenesys for acquiring 100% shareholding of Mugenesys by DRC and our subsequent intimation dated October 12, 2021 regarding extension of timeline till January 31, 2022 to execute the deal, we wish to inform you that Mugenesys vide its email dated January 31, 2022 has informed the Company that its management has decided to continue as an independent entity and not to get acquired at this time.

Hence, based on above response from Mugenesys, the aforementioned deal stands cancelled.

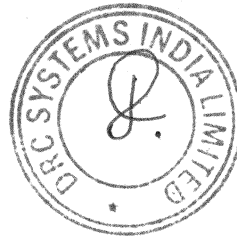
