**Sub: Additional disclosure under Reg. 30 of SEBI (LODR) Regulations, 2015 - Fire incident
Ref: Our disclosure dated 19th Dec., 2023**

With reference to our disclosure dated 19th Dec., 2023 informing a fire incidence in one of stock yards of the Mill, the additional details pursuant to Reg 30 of SEBI (LODR) Regulations, 2015 are as under:

(I) At the time of occurrence of fire:


- expected quantum of loss/damage caused: **Approx. Rs. 2 Crores (Rupees Two Crores)**
- whether loss/damage covered by insurance or not including amount: **Yes, covered by insurance; Amt: Rs. 2 Crores (Rupees Two Crores).**
- estimated impact on the production/operations in case of strike/lockouts: **Not Applicable/Nil**
- factory/unit where the strike/lock out takes place including reasons for such strike: **Not Applicable/Nil**

(II) Regularly, till complete normalcy is restored:

- insurance amount claimed and realized for the loss/damage: **Under process.**
- the actual amount of damage caused due to fire: **Rs. 2 Crores (Rupees Two Crores)**
- details of steps taken to restore normalcy and impact of the incidence on production, financial of the entity:
Immediate steps were taken to control the fire with the help of local administration. There is no human causality in the above accident. The plant operations are unaffected due to above incidence as the stock yard is outside of the Mill premises.
