Uddhav Thackeray slams Shiv Sena govt for 'demolishing' sakha in Mumbra

Thane, Nov 11 : Amid the ongoing tussle between Shiv Sena and UBT Shiv Sena in Maharashtra, Uddhav Thackeray on Saturday slammed the Eknath Shinde government in the state and said that those 'high on power' will be taught a lesson.

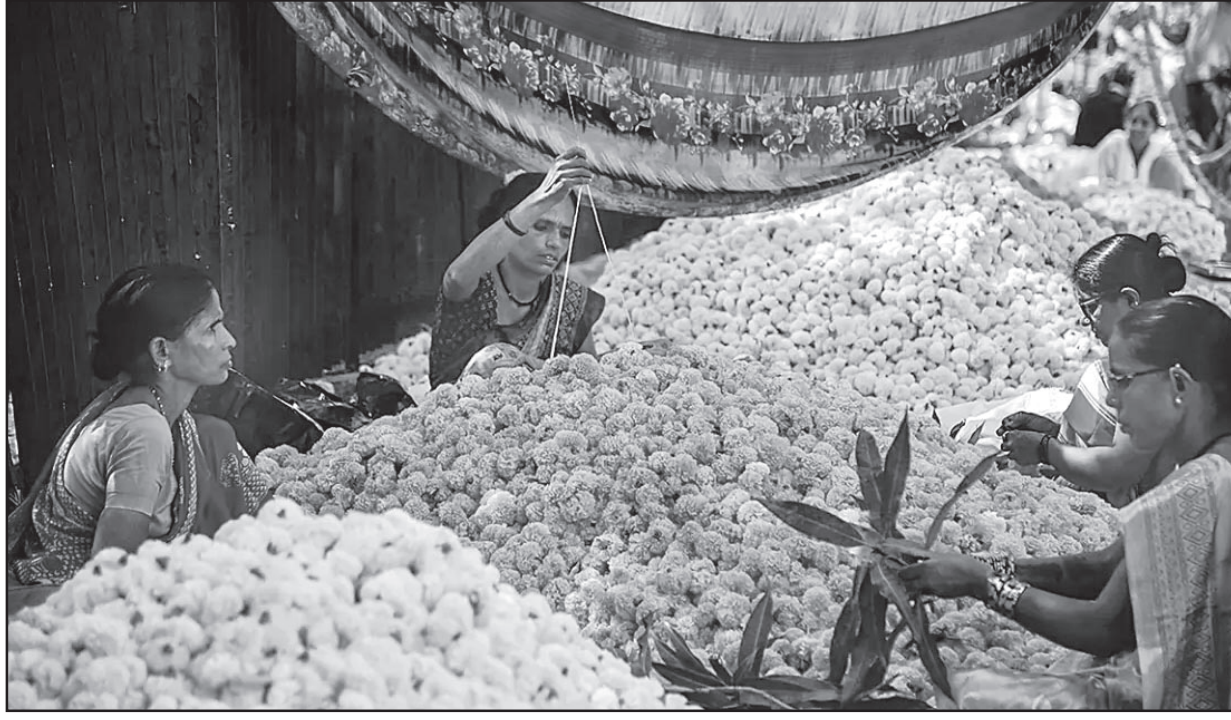
Thackeray on Saturday, along with top leaders of the Sena (UBT), went to Mumbra in Thane to visit the razed sakha which was demolished on November 2 but had to face resistance from workers of the CM's Shiv Sena, who also showed black flags. "Those who are high on power bulldozed the sakha. I have come here to show you the bulldozer. Our posters were torn. We will tear your arrogance into pieces in the polls," Uddhav said while

addressing the party workers in Mumbra.

Since the split of the Shiv Sena and the merger of Shinde faction with BJP, there has been a continuous war of words between the two parties.

Fresh tensions simmered between the Shiv Sena and the Uddhav Sena in Maharashtra after the Shinde faction bulldozed a 25-year-old Shakha of the Shiv Sena in Mumbra on November 2. "Our lamd (Sakha) has been encroached upon. We have all the documents. The Shakha will assemble every day," the former CM said.

Cautioning the administration and the police, Thackeray said, "You are not slaves of the thieves. You have protected the thieves, but the thieves have disturbed the honeycomb. Now the honeybees will sting you."

BJP leader from Marathwada blocks road for equitable distribution of water

Jalna, Nov 11 (UNI) : The issue of the rightful release of water from the dams in north and western Maharashtra to Jayakwadi dam in Chhatrapati Sambhajnagar district of Marathwada region flared up on Saturday when BJP leader Satish Ghatge-Patil staged a protest by blocking Solapur-Dhule highway in Ambad taluka of the district.

As per the equitable water distribution formula, 8,608 TMC water should be released into Jayakwadi dam from upstream dams in Nashik and Ahmednagar areas but due to pressure from political leaders in these areas, the authorities have not been releasing water even though it is the right of farmers.

Angry over this, Ghatge refused to get up from the spot until he gets a guarantee in writing about the rightful release of water despite getting an assurance from superintending engineer of the Water Resources department over the phone.

At last, police detained many protesters, including Ghatge, and restored the traffic.

Ghatge gave a stern warning that if the rightful share of water is not released to Marathwada by November 25, then he will intensify his agitation.

Eatery owner murdered in Nagpur by two staffers over financial dispute

Nagpur, Nov 11 (PTI) : An eatery owner was murdered in the early hours of Saturday allegedly by two of his employees over a financial dispute in Nagpur in Maharashtra, a

police official said. **Raju Bhaurao Dhengre (48) was hit on the head with a wooden log and strangled in his eatery in Pachgaon on the Nagpur-Umred road at around 3:30am, the**

Kuhi police station official said. "Two of this employees wanted to go for Diwali vacations to their native Madhya Pradesh. There was some disagreement and argument over the salary and bonus of the accused, who later killed Dhengre when he was asleep," he said.

Khadse thanks Maha CM for arranging air-ambulance during his illness

Mumbai, Nov 11 (UNI) : Senior Nationalist Congress Party (Sharad Pawar Group) leader Eknath Khadse, who suffered a heart attack last week, called up Maharashtra Chief Minister Eknath Shinde on Saturday to express his gratitude for making available the state government's air ambulance to shift him from Jalgaon to Mumbai.

"I thanked the CM for his prompt help... I also told the CM that if he had

not sent his air ambulance promptly that evening, my life would have 'taken off' from this world!" Khadse said from his hospital bed.

The 71-year-old leader revealed how after he suffered a cardiac arrest at his native Jalgaon last Sunday his aides had decided to book an air ambulance as a precaution, to shift him to Mumbai or any other location as required.

"However, that air ambulance did not get the

air traffic control (ATC)'s clearance for taking off, for some reasons..." he recalled.

Then, his daughter and state NCP Women's Wing President Rohini Khadse got into the act and called up the CM to request the ATC to give permission for the air ambulance to fly to Mumbai. To the Khadses' pleasant surprise, the CM offered to send another air ambulance, kept on standby for the government, to fly to

Jalgaon and pick up the ailing NCP leader. Accordingly, late on Sunday, Khadse, a Member of Legislative Council, was airlifted to the Bombay Hospital where he was put under the care of some of the top cardiac specialists in the city. Three days later, around Wednesday, Khadse underwent a successful angioplasty and has recovered very well from the nasty health scare that sent concerns in NCP and state political circles.

Victims' Bodies Handed Over to Kin After DNA Test

Raigad, Nov 11 : The bodies of 11 persons killed recently in a factory fire in Maharashtra's Raigad district have been handed over to their families, even as the company has declared a payout of Rs 30 lakh for each of the victims' kin, a police official said on Saturday. Since the bodies were badly charred, DNA tests were conducted to ascertain the identity of the victims, the police official said. The bodies were handed over to the victims' kin on Friday and were taken to their respective native places for final rites.

The pharma company, Blue Jet Healthcare, has announced financial assistance of Rs 30 for each of the victims' kin, the official said, adding that the first such payout was made on Friday. Eleven persons lost their lives and seven suffered injuries after a fire

erupted at the company's plant at Mahad MIDC, 170 km from Mumbai, on November 3. The preliminary probe suggested that it was triggered by an electric short circuit, an official had said. A senior official of the pharmaceutical company has been booked for alleged culpable homicide following the death of 11 persons in their factory, the police said on Friday. While the senior employee who was responsible for the plant's maintenance has been arrested, two others have also been named in the case, an official had said.

Based on a complaint lodged by one of the injured labourers, a first information report was registered under sections 304 (culpable homicide but not amounting to murder), 308 (attempt to commit culpable homicide) and other relevant provisions of the Indian Penal Code, the official said.






ED issues fresh summons to ex Mum Mayor Pednekar

Mumbai, Nov 11 (UNI) : The Enforcement Directorate (ED) on Saturday issued fresh summons to former Mumbai Mayor Kishori Pednekar in connection with the Covid-19 body bag scam, a central agency official

confirmed. Pednekar hadn't appeared before the agency when he was earlier summoned Wednesday. After she requested a four-week extension to gather documents, the agency reissued the same summons

for November 23. According to sources, Pednekar was allegedly involved in inflating the cost of body bags in the BMC's procurement process as per a FIR registered by Economic Offences Wing's (EOW) in this connection. The




investigation by the EOW allegedly revealed that two vendors were finalised after the bidding process in April, 2020. The first company, Care Solution, was ready to supply body bags after negotiations at a rate of Rs 2,583 per unit. Pednekar, in her position as mayor, allegedly called Haridas Rathod, who was in charge of the Central Purchase Department, at her bungalow and told him to award the contract to Vedanta Innotech.
