There are various warehouses and godownsir bhiwandi. In these warehouses, companies collect huge quantities of goods and send them to other cities for sale. Six companies had stored goods in one such warehouse. The warehouse owners have committed fraud by selling goods worth Rs 6 crore 50 lakh 21 thousand 741 of various companies. In this case, Narpoli police has registered a case against Jayanti Lal Dedhia and Jayesh Jayanti Lal Dedhia under Section 407,409,34 of IPC on the complaint of Mulud resident businessman Surendra Kumar Shreshirai Gupta, According to the police, Javanti Lal Dedhia and Jayesh Jayanti Lal Dedhia have a warehouse named Jayesh Storage in Rahnal village. In this warehouse, from the month of September till now, goods worth Rs 1,95,55,162 of Shri Sainath Marketing, goods worth Rs 1.95.55.162 of Sunil Enterprise Company, goods 1,95,95,162 of Sunii Enterprise Company, good worth Rs 39,01,537 of Zee Rab Tech Company, Zenith Industrial Company Goods worth Rs 1,62,00,000, goods worth Rs 1,53,31,779 of Elastochemolmpex India Company and goods worth Rs 79,560 of Adani International Company, goods worth Rs 1,95,55,162 of complainant Surendra Gupta's company, totaling Rs 6 crore, Various goods worth Rs 50 lakh 21 thousand 741 were collected and kept.
