Sub: Passing of resolution(s) through electronic voting and poll conducted at the 29th Annual General Meeting of Capfin India Limited held on September 30, 2021.

I, Deepanshu Bansal, a Chartered Accountant in Practice (FCA 526717 and FRN No.026196N), was appointed as Scrutinizer for the purpose of the poll taken on the below mentioned resolution(s), at the 29th Annual General Meeting of the Equity Shareholders of Capfin India Limited held on 30th September, 2021 at 5:00 P.M. through Video Conferencing ("VC") / Other Audio Visual Means ("OAVM"). Our responsibility as a Scrutinizer was to ensure that the voting process was conducted in a fair and transparent manner and submit a Scrutnizer's Report on the voting on the resolutions based on the reports generated from the electronic system.

The Company held the 29th AGM on September 30th, 2021 through video conferencing at 5:00 P.M. in accordance with the provisions of Companies Act, 2013 (the Act) read with the General Circular numbers 20/2020, 14/2020, 17/2020, 02/201 dated May 5, 2020, April 13, 2020, April 8, 2020 AND 13th January, 2021 respectively issued by the Ministry of Corporate Affairs.

The Company hosted the notice of AGM on its website, website of the agency providing the platform for remote e-voting and e-voting during the AGM and also intimated the same to BSE Limited on 18th August, 2021

The Company informed that on the basis of the Register of Members and the list of Beneficial Owners made available by Indus Portfolio Pvt Ltd, the Registrar and Share Transfer Agent ("RTA") of the company and the depositories viz., National Securities Depository Private Limited (NSDL) and Central Depository Services (India) Limited (CDSL), respectively the company completed dispatch of notice of AGM on 7th September, 2021 by E-mail to 159 members who had already registered their email ids with the Company/depositories.

Voting rights were reckoned as on 23rd September, 2021, Thursday, being the cut-off date for the purpose of deciding the entitlements of members for remote e-voting and e-voting during the AGM.

The Company has appointed National Securities Depository Limited (NSDL) as the service provider for extending the facility of electronic voting to the shareholders of the Company from 27th September, 2021 (9.00 a.m.) to 29th September, 2021 (5.00 p.m).

In keeping with Regulation 44(1) and 44(2) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and as prescribed under Rule 20(4)(xiii) of the Companies (Management and Administration) Amendment Rules, 2015, for the purpose of ensuring that Shareholders who have cast their votes through remote e-voting do not vote again at the General Meeting, the Scrutinizer shall have access after closure of period of remote e-voting and before the start of General Meeting, to only such details relating to Shareholders who have cast their votes through remote e-voting, such as their names, DP ID & Client ID/ folios, number of shares held but not the manner in which they have voted.

Accordingly, National Securities Depository Limited (NSDL), the remote e-voting agency provided us with names, DP ID & Client ID/folios and shareholding of members who had cast their votes through remote e-voting.

The e-voting results were unblocked by me on1st October, 2021 in the presence of two witnesses. For further details kindly refer my Scrutinizer's report dated 4th October, 2021 attached herewith.
