To consider and, if thought fit, to pass, with or without modifications, the following resolution as a Special Resolution:

"RESOLVED THAT pursuant to the provisions of Sections 180(1)(a) and all other applicable provisions, if any, of the Companies Act, 2013 read with the rules made thereunder (as amended from time to time), and pursuant Regulation 24 (5) of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (as amended from time to time) and any other applicable laws, rules, regulations and guidelines, the provisions of the Memorandum and Articles of Association of the Company, and subject to such approvals, sanctions, consents and permissions, as may be required, consent of Members of the Company be and is hereby accorded to authorize the Board of Directors of the Company (hereinafter referred to as the "Board" which term shall be deemed to include any committee which the Board may constitute to exercise its powers, including the powers conferred by the Resolution) for the proposed sale of the equity share capital in the Maharashtra Border Check Post Network Limited [a Special Purpose Vehicle of the Company ("SPV")], which is held by the Company (including through its nominees), out of which 49% shares will be sold initially by the Company to Adani Road Transport Limited (the "Buyer") along with an option for the Buyer to acquire the remaining stake, in one or more tranches, subject to inter alia the satisfaction of the relevant conditions precedent and receipt of requisite regulatory approvals/consents (the "Proposed Transaction") for a total enterprise value of INR 1680 crores , subject to inter alia such adjustments and on such terms and conditions with such modifications as stated in the share purchase agreement and other ancillary agreements dated August 16, 2021, (collectively the "Transaction Documents") entered into by the Company with, inter alia, the Buyer and the SPV for the Proposed Transaction.

RESOLVED FURTHER THAT for the purpose of giving effect to this resolution, the Board and any of the committee thereof as may be delegated by the Board from time to time be and is hereby authorized to do all such acts, deeds, matters and things, as may be necessary, proper or desirable and to settle

NOTES:

 In view of the COVID-19 pandemic and the need for ensuring social distancing, the Government of India, Ministry of Corporate Affairs ("MCA") allowed conducting Extraordinary General Meeting through video conferencing (VC) or other audio-visual means (OAVM) without the physical presence of Members at a common venue. Accordingly, MCA issued Circular No. 14/2020 dated April 08, 2020, Circular No. 17/2020 dated April 13, 2020, Circular No. 20/2020 dated May 05, 2020, Circular No. 22/2020 dated June 15, 2020, Circular No. 33/2020 dated September 28, 2020, Circular No. 39/2020 dated December 31, 2020 and Circular No. 10/2021 dated June 23, 2021 ("MCA Circulars"), prescribing the procedures and manner of conducting the EGM through VC/OAVM. MCA vide its Circular No. 02/2021 dated January 13, 2021 extended the time line for holding of Extra-Ordinary General Meetings through VC/OAVM till December 31, 2021. Securities and Exchange Board of India ("SEBI") also vide its Circular No. SEBI/HO/CFD/CMD1/CIR/P/2020/79



dated May 12, 2020 and Circular No. SEBI/HO/CFD/CMD2/CIR/P/2021/11 dated January 15, 2021, permitted holding of EGM through VC/OAVM which was further extended by its circular dated January 15, 2021 ("SEBI Circulars") till December 31, 2021. In compliance with the applicable provisions of the Companies Act, 2013, MCA Circulars and applicable provisions of the SEBI Circulars, the Extraordinary General Meeting of the Members will be held through VC/ OAVM. Hence, Members can attend and participate in the EGM through VC/OAVM only.

- 2. Since this General Meeting is held through VC/OAVM the physical attendance of members is dispensed with and no proxies would be accepted by the. Accordingly, No attendance slip has been sent along with this Notice of the Meeting as the meeting is held through VC/OAVM. However, the Body Corporates are entitled to appoint authorised representatives to attend the EGM through VC/OAVM and participate thereat and cast their votes through e-voting.
- 3. Institutional/Corporate Shareholders (i.e. other than individuals / HUF, NRI, etc.) are required to send a scanned copy (PDF/JPG Format) of its Board or governing body Resolution/Authorization etc., authorizing its representative to attend the EGM through VC/OAVM on its behalf and to vote through remote e-voting. The said Resolution/Authorization shall be sent to the Scrutinizer/RTA by email through its registered email address to <u>nilesh.dalwadi@linkintime.co.in</u>
- 4. The Members can join the EGM in the VC/OAVM mode 30 minutes before and after the scheduled time of the commencement of the Meeting by following the procedure mentioned in the Notice. The facility of participation at the EGM through VC/OAVM will be made available to atleast 1,000 members on first come first served basis. This will not include large Shareholders (Shareholders holding 2% or more shareholding), Promoters, Institutional Investors, Directors, Key Managerial Personnel, the Chairpersons of the Audit Committee, Nomination and Remuneration Committee and Stakeholders Relationship Committee, Auditors etc. who are allowed to attend the EGM without restriction on account of first come first served basis.
- 5. The attendance of the Members attending the EGM through VC/OAVM will be counted for the purpose of reckoning the quorum under Section 103 of the Companies Act, 2013.
- 6. The Explanatory Statement, pursuant to Section 102 of the Companies Act, 2013 relating to Special Business to be transacted at the EGM through VC/OAVM is annexed hereto.
- 7. In line with the aforesaid MCA Circulars, and considering the difficulties caused due to the Covid-19 pandemic, MCA and SEBI have dispensed with the requirement of printing and sending physical copies of the Notice of this Meeting, hence the Notice has been sent via email to all those members who have registered their email ids with the Company or the Registrar and Transfer Agent or the Depositories.
- 8. Members who have not registered their e-mail address are requested to register the same in respect of shares held in electronic form with the Depository through their Depository Participant(s) and in respect of shares held in physical form by writing to the Company's Registrar and Share Transfer Agent, M/s. Link Intime India Private Limited, at <u>ahmedabad@linkintime.co.in.</u>
- 9. In line with the MCA Circulars and the SEBI Circulars, the Notice calling the EGM has been uploaded on the website of the Company at www.sadbhavinfra.co.in The Notice can also be accessed from the websites of the Stock Exchanges i.e. BSE Limited and National Stock Exchange of India Limited at www.bseindia.com and <u>www.nseindia.com</u> respectively and is also available.



10. Relevant documents referred to in the accompanying Notice and Explanatory Statement are open for inspection by the members in electronic mode.

11. Voting through electronic means

- i. In compliance with the provisions of Section 108 of the Companies Act, 2013, read with Rule 20 of The Companies (Management and Administration) Rules, 2014, as amended from time to time, and Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (as amended), the Company is providing facility of remote e-voting to its Members in respect of the business to be transacted at the EGM. For this purpose, the Company has entered into an agreement with Link Intime India Private Limited ("LIIPL") for facilitating voting through electronic means, as the authorized e-Voting's agency. The facility of casting votes by a member using remote e-voting as well as the e-voting system on the date of the EGM will be provided by LIIPL.
- ii. The remote e-voting period commences on Sunday, 12th September, 2021 (9:00 a.m. IST) and ends on, Tuesday, 14th September, 2021 (5:00 p.m. IST). During this period, Members holding shares either in physical form or in dematerialized form, as on Wednesday, 8th September, 2021 i.e. cut-off date, may cast their vote electronically. The e-voting module shall be disabled by LIIPL for voting thereafter. Once the vote on a resolution is cast by the Member, he / she shall not be allowed to change it subsequently or cast vote again.
- iii. The voting rights of shareholders shall be in proportion to their shares in the paid up equity share capital of the Company as on the cut-off date as mentioned above.
- iv. Mr. Ravi Kapoor, Practicing Company Secretary, Proprietor of M/s. Ravi Kapoor & Associates (M. No.: FCS 2587; CP No: 2407) (Shaival Plaza, 4th Floor, Gujarat College Road, Ellisbridge, Ahmedabad: 380006) has been appointed as the Scrutinizer to scrutinize the voting and remote e-voting process in a fair and transparent manner.
- v. The Scrutinizer shall submit, not later than three days from the conclusion of EGM through VC/OAVM, a consolidated scrutiniser's report of the total votes cast in favour or against, if any to the Chairman or a person authorised by him in writing who shall countersign the same. Thereafter, the Chairman or the person authorised by him in writing shall declare the result of the voting forthwith.
- vi. The Results declared along with the Scrutinizer's Report shall be placed on the Company's website <u>www.sadbhavinfra.co.in</u> and on the website of Link Intime India Private Limited immediately after the result is declared by the Chairman; and results shall also be communicated to the Stock Exchanges where the shares of the Company are listed.
- vii. The resolutions shall be deemed to be passed on the date of the EGM through VC/OAVM, subject to receipt of requisite number of votes.

As per the provisions of Section 180(1)(a) of the Companies Act, 2013 read with applicable rules framed thereunder, each as amended from time to time, the Board of Directors of the Company (the "**Board**") requires the consent of the Company in a general meeting, to sell, lease or otherwise dispose of the whole or substantially the whole of the undertaking(s) of the Company. Also pursuant to Regulation 24(5) of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (as amended from time to time) a listed entity shall not dispose of shares in its material subsidiary resulting in reduction of its shareholding (either on its own or together with other subsidiaries) to less than fifty percent or cease the exercise of control over the subsidiary without passing a special resolution in its General Meeting.

As the Members are aware, the Company has executed share purchase agreements ("**SPA**") and other ancillary agreements on August 16, 2021 *inter alia* with Adani Road Transport Limited (the "**Buyer**"), for the proposed sale of the equity shares capital in the Maharashtra Border Check Post Network Limited [a Special Purpose Vehicle of the Company (SPV)], which is held by the Company (including through its nominees), out of which 49% shares will be sold initially by the Company to the Buyer along with an option for the Buyer to acquire the remaining stake, in one or more tranches, subject to *inter alia* the satisfaction of the relevant conditions precedent and receipt of requisite regulatory approvals/consents (the "**Proposed Transaction**").

The consideration of the Proposed Transaction is calculated on the total enterprise value of INR 1,680 Crores (Rupees One Thousand Six Hundred Eighty), to be paid by the Buyer to the Company subject to *inter alia* such adjustments, the satisfaction of the relevant conditions precedent and receipt of requisite regulatory approvals/consents as detailed under the Transaction Documents and accordingly the final consideration payable to the Company at the time of closing may vary.

Upon completion of the Proposed Transaction, the Company will continue to focus on its core expertise of development of road projects and proposes to utilise the sale proceeds for reducing debt and/or injecting equity if required for the undergoing Hybrid Annuity Model Projects. Post completion of the Proposed Transaction, the Company will continue to own and operate 3 (three) operational Build Operate Transfer ("**BOT**") road project companies and of the 9 (nine) Hybrid Annuity Model Projects, 3 (three) projects are operational having achieved Provisional Completion Date and remaining 6 (six) projects are under various stages of completion.

Further, Members are aware that the Company i.e. Sadbhav Infrastructure Project Limited is in a process of merger with it's Holding Company i.e. Sadbhav Engineering Limited vide resolution passed by Board on October 19, 2019, pursuant to which the scheme of amalgamation ("Scheme") was filed before the Hon'ble National Company Law Tribunal, Ahmedabad Bench ("NCLT"). The NCLT passed an order dated December 01, 2020, directing the Company to convene the meeting of Equity Shareholders, Secured Creditors and Unsecured Creditors and procure the requisite majority for the



approval of the said Scheme. Accordingly, the meeting of Equity Shareholders, Secured Creditors and Unsecured Creditors was conveyed by the Company on January 29, 2021 and requisite majority was procured from the relevant stakeholders for the Scheme and the Scrutinizers Report has been received from CS Ashish Shah, confirming the approval of the Scheme by the Stakeholders with requisite majority. Now, the Company is in the process of taking directions from NCLT for completing the merger process in accordance with the Scheme.

Members are also aware that upon coming into effect of the Scheme by NCLT, as per the share exchange ratio ("Share Exchange Ratio") under the Scheme, each shareholder holding 3 (three) equity shares of INR 10/- each in the Company shall be allotted 1 (one) equity share of Re. 1/- fully paid up in Sadbhav Engineering Limited. Further, it is informed by the Board that the Proposed Transaction will not require any change/amendment in either the Scheme and/or the Share Exchange Ratio.

The Board recommends the resolutions in Item No.1 of the Notice for your approval as a special resolution. Accordingly, approval of the Members of the Company is sought to authorize the Proposed Transaction and all matters related thereto.
