#### NOTES TO THE UNAUDITED FINANCIAL RESULTS

- The unaudited financial results of Sanathnagar Enterprises Limited ("the Company") for the quarter and nine months ended 31-December-20 have been reviewed by the Audit Committee and approved by the Board of Directors at its meeting held on 20-January-21, The financial results for the quarter and nine months ended 31-December-20 have been subjected to limited review by the Statutory Auditor of the Company who have expressed an unmodified conclusion.
- 2 During the nine months ended 31-December-20, the Company has used cash in operations amounting to ₹ 2.59 Lakhs and has negative net worth of ₹ 1,166.19 Lakhs as at 31-December-20.
  - The Company has secured continued financial support letter from its parent company namely Macrotech Developers Limited to meet its day to day cash requirements and settle any liability, which may arise. Basis this, management of the Company believes that risk of material uncertainty has been significantly reduced and the Company shall be able to continue for a foreseeable future. Accordingly, these financial results have been prepared using the going concern basis.
- 3 The Company is evaluating Business Options which will ensure utilization of the unutilised Minimum Alternate Tax Credit of ₹ 343.27 Lakhs and Input Tax Credit of ₹ 133.13 Lakhs as at 31-December-20.
- 4 Disclosure under Ind AS 108 on 'Operating Segment' is not applicable as the Company has only one reportable segment which is real estate development.
- 5 The previous period's/year's figures have been regrouped, re-arranged and reclassified wherever necessary to conform for current period's presentation.
