Details of the violation(s)/contravention(s) committed or alleged to be committed	The order has been passed by GST Authority on the contention that the Company has availed inadmissible TRAN-1 credit. The GST Authority has ordered for recovery of the same along with applicable interest and penalty.

Based on assessment of facts and prevailing law, the Company is of the view that the penalty levied is arbitrary and unjustified. The Company will file necessary appeal with the appellate authority in this regard. There is no material impact on the Company’s financials or operations due to the said order.
