

Miso & natto may cut mortality risk

Tigher intake of fermented soy products, such as miso **L** and natto, is associated with a lower risk of mortality, claims a study conducted in Japan. The findings, published in the British Medical Journal, should be interpreted with caution as they may have been affected by unmeasured factors, the researchers said.

In Asian countries, especially Japan, several types of soy products are widely consumed, such as natto -- soybeans fermented with Bacillus subtilis bacteria, miso or soybeans fermented with Aspergillus oryzae

bacteria, and tofu or soybean curd. However, it is still unclear whether different soy products, especially fermented soy products, are associated with specific health effects, according to the researchers, including those from Osaka University Graduate School of Medicine in

They analysed the association between several types of soy products and death from any cause, and from cancer, total cardiovascular disease, respiratory disease, and injury. The team based its findings on 42,750 men, and 50,165 women aged 45-74 years, who were taking part in a study based in 11 of Japan's public health centre areas.

A study found that people lie in order to appear more honest at events when they feel that their reputation is at stake, and may over tell the truth to prove themselves right

eople may lie sometimes to appear honest if events that turned out in their favour seem too good to be true, according to a study. "Many people care greatly about their reputation and how they will be judged by others, and a concern about appearing honest may outweigh our desire to actually be honest, even in situations where it will cost us money to lie," said Shoham Choshen-Hillel, a senior lecturer at The He-University Jerusalem in Israel.

"Our findings suggest that when people obtain extremely favourable outcomes, they anticipate other people's suspicious reactions, and prefer lying and appearing honest over telling the truth, and appearing as selfish liars," Choshen-Hillel said.

tal Psychology: General, found similar findings about lying to appear honest in a series of experiments conducted with lawyers, and college students in Israel, as well as online participants in the US and UK.

In one experiment with 115 lawyers in Israel, the participants were told to imagine a scenario where

would cost between 60 and 90 billable hours. The lawver would be working in an office where the client wouldn't know how many hours were truly spent on the case.

Half of the participants were told they had worked 60 hours on the case while the other half were told they worked 90 hours. Then they were asked how many hours they would bill the client. In the 60-hour group, the lawvers reported an average of 62.5 hours, with 17 per cent of the group lying to inflate their hours.

Tore than hackers, people are worried LV Labout friends, family and others who can listen to their conversations via smart speakers, reveals new research. A survey by University of British Columbia (UBC) researchers in Canada found that people feared potential misuse of the device from people they actually live with and know.

"They worried that their housemates could order stuff online, overhear private conversations or access other people's reminders, calendars and phone contacts," explained Konstantin Beznosov, a professor of electrical and computer engineering who specializes in cybersecurity at UBC.

"Of course, they were aware these actions could well be unintentional —



such as a child accidentally using the last-number-dialled feature to call up their parent's employer, for exam-

They found that participants not only worried about keeping their data safe from the manufacturer or other entities; they also feared potential misuse of the device from people they know. Interestingly, the nature of the concern depended on the participant's "mental model" or technical understanding of how smart speakers work, said study primary author Yue Huang, a PhD student in electrical and computer engineering.
