IIFL clarification on SEBI order against IIFL Commodities Ltd (IICL)

Ref: Securities & Exchange Board of India (SEBI) Order dated February 22, 2019 in the matter of IIFL Commodities Ltd (Formerly India Infoline Commodities Ltd)

The referred order rejects the application dated December 23, 2015, filed by IICL for registration as commodities derivatives broker, on the grounds of not 'fit and proper'. IICL does not have any outstanding dues to any clients. IICL also does not have any proprietary position. The order mentions that SEBI has initiated similar enquiry proceedings against approximately 300 brokers and there will be no discrimination. However, IICL is seeking legal advice as regards to going for an appeal, in this matter. **We would like to clarify to all our stakeholders and clients that this order has no impact on businesses of other companies of IIFL Group.**
