

## Wait for appointment...

Rakesh could not get up but other members took his son to a private hospital where he is struggling for life. Town Inspector (TI) Manganon Goyal, Parmanand Goyal said that he was busy with the case of tribal ransacking police station a day ago and was not aware of Rakesh Patidar's suicide. "I am sending an inspector immediately to collect details of the incident," said Patidar.

## Hopes brighten for...

"MP has a written recorded history since 1908 of basmati production in 13 districts. Records of supplying seeds to farmers in MP in 1944 are found in the records of Scindia state," Chouhan had then said. Replying to Punjab CM, Chouhan had then said that basmati exporters from Punjab and Haryana are procuring basmati rice from MP. This is also supported by Government of India data of export from Mandideep (MP). Madhya Pradesh's argument for GI tag - Basmati rice in the state is largely grown in and around the 13 districts of Morena, Bhind, Sheopur, Gwalior, Datia, Shivpuri, Guna, Vidisha, Raisen, Sehore, Hoshangabad, Narsinghpur and Jabalpur. An estimated 80,000-100,000 farmers cultivate the crop in these areas in over 200,000 hectares of land, as per the state government's assessment. Madhya Pradesh contends that it has historical records since 1908 of basmati production in the 13 districts and has records of supplying seeds to farmers in MP in the year 1944 by the erstwhile Scindia State.

## Assuming every Covid...

The top court referred to a recent verdict of June 30, in which it had directed the National Disaster Management Authority to recommend within six weeks appropriate guidelines for ex-gratia assistance on account of loss of life to the family members of persons, who died due to COVID-19. It said, "in that verdict the court has taken a view with regard to humanity and not due to negligence. The government is yet to come out with the policy. If you have any suggestion with regard to implementation of that policy, you can approach the competent authority". At the outset, advocate Sriram Parakat, appearing for the petitioner, said that his petition is different as it brings into account an element of negligence and compensation for the deaths which have happened due to medical negligence. The bench noted that since the petition was filed in the month of May, a lot of developments have taken place. "We have taken suo motu cognizance on Covid preparedness and a National Task Force has been constituted by this court which is looking into several aspects," the bench said. The bench further told Parakat that, "it was such a wave that it affected the entire country" and the court cannot make a general presumption of medical negligence.

## Several feared drowned...

A woman died in hospital after she was rescued from the river, Assam State Disaster Management Authority (ASDMA) Chief Executive Officer Gyanendra Tripathi told PTI. The deceased was identified as Porimita Das who hails from Guwahati and was working as a faculty in a college in Majuli. Three more persons are undergoing treatment at the Jorhat Medical College and Hospital, a senior doctor said. Jorhat Deputy Commissioner Ashok Barman told PTI that 42 people have been rescued so far and no body has been recovered from the water yet. "After sinking, it swept around 1.5 km away and stuck in the bed of the river. The boat is upside down now and we are not able to turn it around. Once we can do that, we will be able to see if anybody is stuck there," he added. The Army will join the operations on Thursday morning with some advanced machines, Barman said. The NDRF and SDRF have started a rescue and search operation, but they are facing difficulties as it was pitch dark. President Ram Nath Kovind and Prime Minister Narendra Modi expressed grief over the boat accident. "My thoughts go out to the victims, survivors and their families. Rescue and relief efforts are on to save as many lives as possible," Kovind said. "All possible efforts are being made to rescue the passengers. I pray for everyone's safety and well-being," Modi tweeted. Chief Minister Himanta Biswa Sarma said he is personally supervising the rescue operations.

## Bypoll preparations: HC...

A division bench comprising Chief Justice Mohammed Rafiq and Justice Vijay Kumar, while hearing the petition, has asked ECI to apprise the court about its preparations of conducting by-elections. The ECI sought two days' time to file a detailed report on preparations for by-polls. While granting time to ECI, the division bench scheduled the next hearing on August 22. Notably, Khandwa Lok Sabha seat is vacant after the death of Nand Kumar Singh Chouhan. Similarly, Prithvipur, Jobat and Raigaon state assembly seats are vacant.

## 56 Airbus...

All 56 aircraft will be installed with indigenous electronic warfare suite," the ministry said. It said the project will give a boost to the aerospace ecosystem in India wherein several MSMEs spread over the country will be involved in the manufacturing of parts of the aircraft. A large number of detail parts, sub-assemblies and major component assemblies of aero structure are scheduled to be manufactured in India. "The programme will act as a catalyst in employment generation in the aerospace ecosystem of the country and is expected to generate 600 highly skilled jobs directly, over 3000 indirect jobs and an additional 3000 medium skill employment opportunities with more than 42.5 lakh man-hours of work within the aerospace and defence sector of India," the ministry said.

## Top Russian...

The top Russian security official held wide-ranging talks with NSA Ajit Doval with a focus on possible security threats to India, Russia and the Central Asian region from the Taliban-ruled Afghanistan. He also met External Affairs Minister S Jaishankar. The Russian statement said a wide range of issues of the Russian-Indian cooperation, as well as a number of topics of the international agenda were touched upon during the conversation. "Opportunities for further development of the special and privileged strategic partnership between Russia and India, including deepening political dialogue at the highest and high levels, were discussed," it said.

# Sorry, no orders on door-to-door vaccination: SC

The Supreme Court on Wednesday junked a PIL filed by YBAI for directions to the Centre for providing "door-to-door" Covid-19 vaccination to all citizens, particularly the elderly, differently abled, weaker sections and those not capable of online registration. It also dismissed another PIL, which demanded

compensation for kin in each Covid death.

A 3-judge Bench headed by Justice Dr Dhananjaya Yashwanth Chandrachud, and also comprising Justices Vikram Nath and Hima Kohli, said: "The vaccination programme is underway and this court is monitoring the progress under the suo motu cognizance. We have also formed a national task

force on the same issue." It noted that at the present stage, it will be difficult to issue generation directions, especially with regard to diversity of conditions and our directions should not infringe upon the administrative powers of the state government, including the door-to-door vaccination.

## 37,875 new Covid cases, 369 deaths

India logged 37,875 new cases of coronavirus infection taking the total tally of Covid-19 cases to 3,30,96,718, while the active cases declined to 3,91,256, according to the Union Health Ministry data updated on Wednesday. The death toll climbed to 4,41,411 with 369 fresh fatalities, according to the data updated at 8 am.
