ALTERATION OF OBJECT CLAUSE CONTAINED IN THE MEMORANDUM OF ASSOCIATION OF THE COMPANY:

"RESOLVED THAT pursuant to the provisions of section 13 and other applicable provisions of the Companies Act, 2013, if any (including any statutory modifications or re-enactment thereof, for the time being in force) and the rules framed there under, subject to the approval of Registrar of Companies, Mumbai, consent of the members of the Company be and is hereby accorded for shifting point no. 9 from Clause III (B) of the Memorandum of Association to Clause III (A) as point no. 3 after point no. 2 and all the points be renumbered. The new Clause III (A) would be read as under:

1. To carry on the business of manufacturers, producers, importers, exporters, marketers, dealers, traders, stockists, processors of all kinds of irons brass, steel, seam less steel, hardware, ironery, turnery tools, metals and metal wares of all kinds, and other machinery, pipes including seamless pipes and tubes including precision tubes and tanks manufacturers, tin plate and tool makers, metal makers, etc.
2. To do software business, creating software to automate business processes of various clients, developing software products, higher software, other IT as well as non IT people, by hardware and software.
3. To purchase, take on lease or in exchange or otherwise acquire any estate, land, buildings, easements or other rights and interest in immovable property, to sell, build, operate, transfer, let on lease, mortgage, hypothecate or otherwise dispose of or grant rights over any immovable property belonging to the Company."

RESOLVED FURTHER THAT any one of the Directors of the Company be and is hereby authorized to execute all such documents, instruments and writings as may be required and to take all such steps and actions and give such directions as may in its absolute discretion deem necessary and to settle any question that may arise in this regard."
