Nagal enters semis, Mukund crashes out Chennai: India's top-ranked tennis player Sumit Nagal defeated unseeded Dominik Palan of the Czech Republic 6-3 6-3 to advance into the semi-final of the Chennai Open here on Friday. The second-seeded Nagal will face third seed Dalibor Svrcina of the Czech in his semi-final on Saturday. Nagal earlier beat SD Prajwal Dev and Giovanni Fonio of Italy en route to the lasteight. Svrcina overcame India's Mukund Sasikumar 6-7(6) 6-2 6-4. In the other quarterfinal, Chun-Hsin Tseng of Taiwan beat Enrico Dalla Valle of Italy 7-5 6-2 and will be up against the

Sweden, Denmark team up for Euro 2029

winner of Luca Nardi and Stefano Napolitano.

Paris: Denmark and Sweden will bid to host the 2029 Women's European Championship, the two federations said Thursday. They are no longer with their Nordic neighbors Norway and Finland after their four-nation bid for the 2025 edition lost out to Switzerland in a final round of voting by UEFA's executive committee last year. The tournament of 16 teams and 31 games requires up to eight stadiums to host. Swedish and Danish soccer leaders announced their bid project in Paris after the annual meeting of UEFA where both had supported its president Aleksander Ceferin in a potentially controversial vote on extending term limits. Earlier at the UEFA congress, Norway was one of three "no" votes, with England and Iceland, in an attempt to separate the term-limit issue from a bloc vote on a wider package of statutes changes.

Tiafoe beats Michelsen, in quarters

Dallas: Top-seeded Frances Tiafoe advanced to the quarterfinals of the Dallas Open with a 6-4, 6-3 victory over 19-year-old fellow American Alex Michelsen on Thursday night. Tiafoe gave himself three match points with a backspinning drop volley that landed so close to the net, it bounced back over to his side. Michelsen had already given up pursuit when the ball bounced. The 26-year-old Tiafoe closed out his first match of the tournament on his first match point when Michelsen put a forehand into the net for Tiafoe's fifth service break. Japan's Yoshihito Nishioka withdrew from the late match, putting France's Adrian Mannarino in the quarterfinals without having played a match. The other round-of-16 winners were No. 7 seed Jordan Thompson of Australia, 6-1, 6-1 over American Denis Kudla, and eighth-seeded German Dominik Koepfer, 6-4, 7-6 (5) over Rinky Hijikata of Australia.

Bryant immortalised with 19-ft statue

Los Angeles: The Los Angeles Lakers unveiled a statue of Kobe Bryant on Thursday, honoring their late superstar with a 19-foot bronze likeness outside their downtown arena. The 4,000-pound statue depicts Bryant in his white No. 8 jersey with his right index finger raised as he walked off the court following his 81point performance against the Toronto Raptors in January 2006. Bryant's widow, Vanessa, said during the dedication ceremony that the statue is the first of three that will be created to honor the five-time NBA champion and top scorer in Lakers history. Another statue will feature Bryant in his No. 24 jersey, which he wore for the second half of his career, while a third will depict Bryant and his daughter, Gianna, who died with him and seven others in a helicopter crash in January 2020.

New Delhi: The Indian Rugby Football Union (IRFU) is set to launch the franchise-based Rugby Premier League (RPL), acting on its stated objective of spreading the sport in the country. The league will feature some of the best 7s rugby talent internationally as well as from India. The league to be played in the 7s format of the sport is slated to be held in September this year and will feature six teams in its inaugural season. "This is a Íandmark moment for India and Indian Rugby,'' Rahul Bose said.

कलम ३०२ (हत्या) आणि २०१ (गुन्ह्याचा पुरावा गायब करणे) अंतर्गत गुन्ह्यांसाठी त्यांना दोषी ठरवण्यात आले. दिल्ली उच्च न्यायालयाने यापूर्वी ट्रायल कोर्टाने त्याला सुनावलेली फाशीची शिक्षा बदलून ती जन्मठेपेत बदलली होती, पण जन्मठेपेची शिक्षा म्हणजे याचिकाकर्त्यांची पूर्ण जन्मठेपेची शिक्षा होईल.

या अनुषंगाने विकलांनी म्हटले आहे की, येथे नमूद करणे उचित आहे की, आयपीसीच्या कलम ३०२ मध्ये स्पष्टपणे दोन शिक्षांचा उल्लेख केला आहे, एक म्हणजे मृत्युदंड आणि दुसरी जन्मठेपेची शिक्षा. यात या दोघांशिवाय इतर कोणत्याही शिक्षेचा

उल्लेख नाही. कलम ३०२ मध्ये सुधारणा करून केवळ जीवनाऐवजी नैसर्गिक जीवन जोडण्याचा कायदेमंडळाचा जाणीवपूर्वक हेतू नाही, असे सादर करण्यात आले आहे. त्यामुळे जीवन म्हणजे केवळ नैसर्गिक असा विचार कायदा करत नाही, असे त्यात म्हटले आहे. जन्मठेपेची शिक्षा नैसर्गिक जीवनापर्यंत समजली जात असेल तर ते दोषी व्यक्तीच्या मूलभूत अधिकाराचे उल्लंघन करते, असे याचिकेत म्हटले आहे. त्यात म्हटले आहे की, खुनाच्या गुन्ह्यासाठी नैसर्गिक जीवनापर्यंत कारावासाची शिक्षा देणे घटनाबाह्य आहे. कारण ते एखाद्या व्यक्तीच्या सुधारणेची संधी पूर्णपणे हिरावून घेते आणि सरकारांनी विहित केलेल्या माफी धोरण व नियमांचे उल्लंघन करते. खंडपीठाने याचिकेवर नोटीस जारी करताना, असाच मुद्दा उपस्थित करणाऱ्या वेगळ्या याचिकेसह टॅग केला. जानेवारी २०१६ मध्ये उच्च न्यायालयाने झा यांना सुनावलेली फाशीची शिक्षा माफी न देता तुरुंगात बदलली होती.

२०१९ पेक्षा नोंदणीकृत मतदारांच्या संख्येत ६ टक्क्याने वाढ झाली आहे. पुण्यात आलेल्या पत्रकार परिषदेत मुख्य निवडणूक आयुक्त राजीव कुमार यांनी सांगितले की, महिला मतदारांची संख्या वाढली आहे. घराघरात तपासणी करून १



मतदारांची नावे मतदार यादीतून काढली आहेत. यात ६७ लाख ८२ हजार ६४२ मतदार मृत झाले आहेत, ७५ लाख ११ हजार १२८ मतदार अनुपस्थित, तर २२,५६८५ मतदारांची नावे दोन वेळा यादीत आली आहेत.

शरिया आधारित अनेक राज्य कायदे रह

मलेशियाच्या सर्वोच्च न्यायालयाचा निर्णय

क्वालालम्पूर: मलेशियाच्या सर्वोच्च न्यायालयाने शुक्रवारी शरिया आधारित अनेक राज्य कायदे रद्द केले आहेत. शरिया आधारित राज्य कायद्यांनी फेडरल अधिकारावर अतिक्रमण केले असल्याचे निरीक्षण न्यायालयाने नोंदवले आहे, तर या निर्णयामुळे देशभरातील धार्मिक न्यायालये खराब होऊ शकतात, अशी भीती वाटणाऱ्या इस्लामवाद्यांनी न्यायालयाच्या निर्णयाचा निषेध केला.

नऊ सदस्यीय फेडरल कोर्ट पॅनेलने विरोधी संचालित केलंटन राज्य सरकारने बनवलेले १६ कायदे अवैध ठरवले, ज्यात लैंगिक छळ, लैंगिक छळ व व्यभिचार आणि क्रॉस ड्रेसिंगपासून खोटे पुरावे देण्यापर्यंतच्या गुन्ह्यांसाठी शिक्षा ठोठावण्यात आली. न्यायालयाने म्हटले आहे की, राज्य त्या विषयांवर इस्लामिक कायदे करू शकत नाही. कारण ते मलेशियाच्या फेडरल कायद्यात समाविष्ट आहेत.

मलेशियामध्ये दुहेरी ट्रॅक कायदेशीर प्रणाली आहे. शरियतमध्ये नागरी कायद्यांसोबत मुस्लिमांसाठी वैयक्तिक आणि कौटुंबिक बाबींचा समावेश आहे. मलेशियातील ३३ दशलक्ष लोकसंख्येपैकी दोनतृतीयांश मलेशियन ज्यांना मलेशियन कायद्यात मुस्लीम मानले जाते, ते मोठ्या प्रमाणात चिनी आणि भारतीय अल्पसंख्याक आहेत. शरिया हा इस्लामिक कायदा आहे, जो कुराण आणि हदिस म्हणून ओळखल्या जाणाऱ्या धर्मग्रंथांच्या संचावर आधारित आहे. २०२० मध्ये केलांटन या ग्रामीण ईशान्येकडील राज्याच्या दोन मुस्लीम महिलांनी न्यायालयीन आव्हान दाखल केले होते, ज्या राज्यांची लोकसंख्या ९७ टक्के मुस्लीम आहे. १९९० पासून केलांटन हे पुराणमतवादी पंन मलेशियन इस्लामिक पार्टी किंवा पीएएसद्वारे शासित आहे. शरिया कायद्यांच्या संरक्षणाची मागणी करत शेकडो पीएएस समर्थक शुक्रवारी न्यायालयाबाहेर जमले.

पीएएसचे सरचिटणीस तकीयुद्दीन हसन यांनी निकालानंतर न्यायालयाच्या इमारतीबाहेर पत्रकारांना सांगितले की, आज आम्ही खूप दुःखी आहोत.
