We wish to inform you that the 78<sup>th</sup> Annual General Meeting of the Shareholders of the Company was held on September 27, 2019 at Chitra Kuti at Ambaghat, Vishalgad, Taluka Shahuwadi, Dist. Kolhapur, Kolhapur-415 101.

Mr. Sudhir Nevatia chaired the meeting and welcomed all the Board Members, other dignitaries and members of the company. The requisite quorum being present, the Chairman called the meeting to order. Four directors of the Company attended the meeting. The Chairman delivered his speech.

The Chairman informed that the Company had provided the Members the facility to cast their vote electronically on all resolutions set forth in the Notice. Members who were present at the AGM and had not cast their votes electronically were provided an opportunity to cast their votes through Ballot Paper i.e. poll at the end the meeting.
