1. APPOINTMENT AS SCRUTINIZER:

4. CUT OF DATE:

The voting right were reckoned as on Wednesday, September 23, 2020 being the Cut-off date for the purpose of deciding the entitlement of members at the remote e-voting and e-voting at the Meeting.

5. REMOTE E-VOTING

Remote E-voting platform was open from **Sunday, September 27, 2020 at 9.00 A.M. to Tuesday, September 29, 2020 at 5.00 P.M.** and members were required to cast their votes electronically conveying their assent or dissent in respect of the Ordinary/Special Resolution, on the e-voting platform provided by CDSL.

6. VOTING AT THE AGM
