Dear Sir,

In regard to the captioned company, as you are aware, the company is currently under Corporate Insolvency Resolution Process (CIRP). As a part of the resolution process, we hereby inform you the resolution plan submitted by the prospective resolution applicant- *Consortium of Patanjali Ayurved Limited ("Lead Partner"), Divya Yog Mandir Trust, through its business undertaking Divya Pharmacy, Patanjali Parivahan Private Limited and Patanjali Gramudyog Nyas (collectively referred as "PAL")*, has achieved an approval from the Committee of Creditors in excess of 66% required pursuant to the Insolvency and Bankruptcy Code 2016. The said voting in this regard was concluded on April 30, 2019 at 8 pm.

As next steps in this regard and in accordance with the Process Memorandum, we will get executed letter of intent (LoI) from PAL and file an application to the Adjudicating Authority (NCLT) to file the approved resolution plan in accordance with Section 30 (6) of the Code.

At this juncture, we hereby affirm that while the above is in line with the duties and powers conferred upon the Resolution Professional under the Insolvency & Bankruptcy Code, 2016, all relevant controls in compliance with the SEBI (LODR) Regulations are put in place to ensure no material, non-public or price sensitive information is published. Further, any material event shall be duly notified to the stock exchanges in accordance with SEBI (LODR) Regulations.
