Notice is hereby given that the 60th Annual General Meeting (AGM) of the Company will be held on Friday, 23rd September, 2022 at 11:30 a.m. through Video Conferencing (VC)/Other Audio-Visual Means (OAVM), to transact the businesses mentioned in the notice sent to the shareholders in compliance with the applicable circulars issued by Ministry of Corporate Affairs (MCA) and the Securities and Exchange Board of India (SEBI). The venue of the meeting shall be deemed to be at MOIL Ltd., MOIL Bhawan, 1-A, Katol Road, Nagpur-440 013.

In compliance with the MCA Circulars and SEBI Circulars, Notice of the AGM along with the Annual Report 2021-22 has been sent through electronic mode to those Members whose email addresses are registered with the Company/Depositories. Members may note that the Notice and Annual Report 2021-22 will also be available on the Company's website www.moil.nic.in. The Notice can also be accessed from the websites of the Stock Exchanges i.e. BSE Limited and National Stock Exchange of India Limited at www.bseindia.com and www.nseindia.com respectively and website of NSDL (agency for providing the Remote e-Voting facility) i.e. www.evoting.nsdl.com

The Company shall be providing the facility of remote e-voting to transact the businesses through National Securities Depository Limited (NSDL).

- i. The E-voting on the resolutions to be passed at the said meeting shall begin on 20th September, 2022 at 9.00 a.m.(IST) and end on 22nd September, 2022 at 5.00 p.m. (IST). During this period, a person whose name is recorded in the register of members or in the register of beneficial owners maintained by the depositories as on the cut-off date (i.e. 16th September, 2022) only shall be entitled to avail the facility of remote e-voting as well as voting in the annual general meeting.
- ii. The e-voting shall not be allowed beyond the said date and time.
- iii. Any person, who acquires shares of the Company and become member of the Company after dispatch of the notice and holding shares as of the cut-off date, may obtain the login ID and password by sending a request at evoting@nsdl.co.in or Company/RTA.
 - a) Only those Members/shareholders, who will be present in the AGM through VC/OAVM facility and have not cast their vote on the Resolutions through remote e-Voting and are otherwise not barred from doing so, shall be eligible to vote through e-Voting system in the AGM.
 - b) Members who have voted through Remote e-Voting will be eligible to attend the AGM. However, they will not be eligible to vote at the AGM.
- iv. Please refer to the Notice of the AGM with regard to instructions for e-voting.
- v. 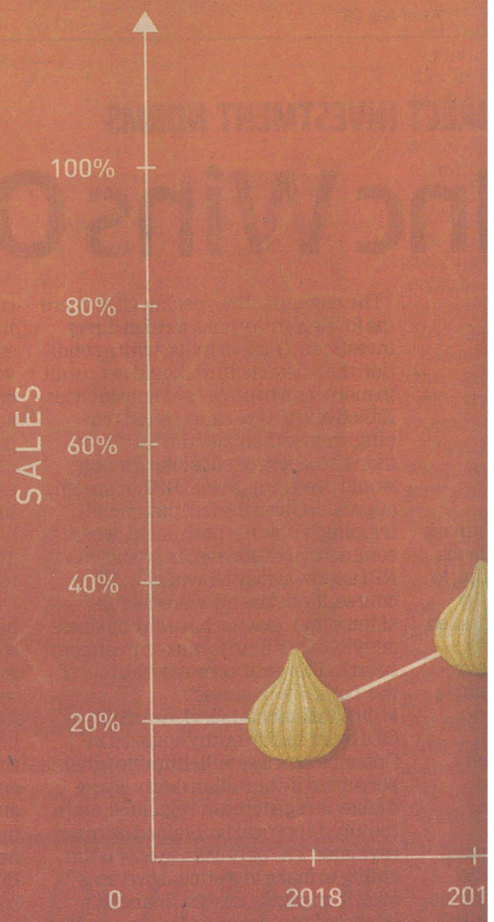
