GQG Partners LLC is the investment manager of the Acquirer and PACs and has made the investment decisions on behalf of the Acquirer and PACs.

- (1) This reflects the aggregate shareholding of the Acquirer and PACs in the Target Company. BBH Emerging Markets Master Fund (PAC with the Acquirer) acquired 4,99,632 equity shares in August 2022 and the Acquirer and some PACs acquired 1,05,972 equity shares in November 2022. Since the aforesaid acquisitions were less than 2%, no filing was required under 29 (2) of the SEBI (SAST) Regulations. Accordingly, the aggregate acquisitions by the Acquirer along with the PACs amounts to 1,13,65,160 equity shares representing 5.33% of the share capital of the Target Company. Between August 23, 2022 and March 15, 2023, the Acquirer and the PACs have disposed-off their equity shares through various modes including several on-market transactions. On March 15, 2023, the shareholding of the Acquirer and the PACs in the Target Company changed in excess of 2% (i.e. by 2.57%). Accordingly, this disclosure is being made to reflect the change of shareholding in excess of 2% since the last disclosure made by the Acquirer and PACs. The number of equity shares held by each Acquirer and PAC (pre and post such disposal) is specified in Annexure 1 below for reference.
- (2) As disclosed in the shareholding pattern filed by the Target Company for the quarter ended December 31, 2022.
- (3) The percentage numbers are on approximate basis and rounded off to the next decimal, wherever applicable.
