Report on the audit of the Standalone Financial Results

Opinion

We have audited the accompanying annual standalone financial results of **SAIANAND COMMERCIAL LIMITED** ("the company") for the quarter and year ended on 31/03/2022, attached herewith, being submitted by the Company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ('Listing Regulations').

In our opinion and to the best of our information and according to the explanations given to us these standalone financial results:
