Sub: Disclosure on impact of Covid-19 on the business of the Company pursuant to the SEBI circular no SEBI/HO/CFD/CMD1/CIR/P/2020/84 dated May 20, 2020

We would like to inform you that, in lieu of the Novel Coronavirus (COVID19) outbreak which has been declared a pandemic and pursuant to the aforesaid SEBI Circular, the Company is taking various measures to ensure the safety and well-being of all employees and is ensuring compliance with the directives issued by the Central Government, State Governments and local administration from time to time in this regard.

The Company is into Broadcasting which is one of the essential businesses to be kept working as per the guidelines issued by the Government. Accordingly, the Company is continuously maintaining the transmission of its channels via the distributors platform namely Tata Sky, Airtel, DEN, GPTPL, Hathway, DD free dish, etc, making payments to Ministry of Information and Broadcasting (MIB) towards the uplinking and downlinking fees of the channel and payments to the satellite space provider.

Further, the Company is also following the policy of 'No pay cut and No job cut' for the employees owing to the social responsibility of a Company and as per the urge of our Hon'ble Prime Minister. The Company is also following 'Work From Home' policy.

However, due to Covid-19 pandemic impact the revenue of the Company has come down substantially. This is mainly because the Company is having lowest advertisement time on the channel nearly as low as 10-15% than usual business.

The total impact on the operations of the Company cannot be completely assessed at this stage.

The Company is continuously monitoring the situation and is in the process of accessing the impact of Covid 19 pandemic and the same will be communicated as and when the information is reasonably assessable.

Further, pursuant to the guidelines issued by BSE Limited and National Stock Exchange of India Limited for submissions of documents on respective Portals in the wake of CoVID-19 virus and following the Work from Home Policy, we are submitting the disclosure in **"SD mode"** to the Exchanges.
