ping up the heavily beaten stocks. The BSE Auto Index, which had underperformed the benchmarks for nearly two years, has made a comeback in the last three months to emerge as the best sectoral index on the BSE after surging by over 24%.

As several auto companies announced that there was a rebound in demand during the festive season, the stocks continued their upward movement. Lower corporate tax rates and better-than-expected quarterly results from companies such as Tata Motors and Maruti Suzuki also supported the sentiment.

Interestingly, Maruti Suzuki, Bajaj Auto and Tata Motors topped the list of best performers on Sensex in the last three months with gains between 28.8% and 37.2%. Shares of Hero MotoCorp rose 18.8% during the same period.

Analysts at Dolat Capital say, though the festival cheer has given some boost to the sector, it is still early to call this a recovery. "The H2FY20 is likely to be difficult, with inventory clean up likely to gain steam with emphasis on bringing down inventory and BS6 transition, which may weigh down volume
