

We have reviewed the accompanying Statement of Standalone Unaudited Financial Results of GITA RENEWABLE ENERGY Limited ("the Company") for the Quarter ended September 30, 2022 and year to date from 1<sup>st</sup> April 2022 to 30<sup>th</sup> September 2022 (hereinafter referred to as the "Statement"), attached herewith.
