This is with reference to the above captioned subject; we would like to inform you that the Board of Directors of the Company in their meeting held on 03rd August 2019, have, inter-alia, considered and approved the following business:

- 1) Pursuant to Regulation 33 of SEBI (LODR), Regulations 2015, Please find herewith the standalone and consolidated Financial Results for the quarter ended 30th June 2019;
- 2) Sh. Joginder singh Dhamija, have resigned from the Directorship of the company, being effective from 03<sup>rd</sup> August 2019, due to his personal reasons. In this regard he has also given a declaration that there is no other Material Reason for his resignation;
- 3) The Board of Directors have appointed Mr. Vivek Gupta as an Additional Director (Non-Executive & Independent Director) of the Company. Mr. Gupta does not hold any equity shares in the Company. Brief Profile and educational qualification of Mr. Vivek Gupta is as

- Sh. Vivek Gupta, Non-executive and Independent Director of the company has been appointed as Chairman of the Board of Directors of the company w.e.f. 03rd August 2019.
- 5) Subject to the consent of the shareholders to be obtained in the AGM, the Board of Directors have recommended the appointment of M/s Deloitte Haskins & Sells, chartered accountants to be the statutory auditors of the company for their 2<sup>nd</sup> term of remaining 4 years.
- 6) Pursuant to Regulation 30 of SEBI (LODR), 2015, the Board of Directors vide their meeting dated 03rd August 2019, have approved, subject to approval of shareholders of the company, the offer upto a maximum of 14,39,000 fully convertible warrants into equity shares on a preferential basis to all or any member of the Promoter Group / Entity.
