3rd COVID wave to be less severe, says BHU scientist

VARANASI, Sept 14 (IANS)

PROFESSOR Gyaneshwer
Chaubey, senior geneticist of the
zoology department in the
Banaras Hindu University (BHU),
has said that the third wave of
coronavirus would be less severe
and deadly, especially for the vac-
cinated group of people, those
who have been cured of the virus
and the children.

He said that people who have
been vaccinated and cured of
COVID-19 would fall under the
protected group during the third
wave.

He added that the wave would
likely hit after, at least, three
months, but the ongoing coron-
avirus vaccination will boost peo-
ple's immunity and help them
resist the wave.

Not going to reopen decision on grant of quota in promotion to SCs and STs: SC

NEW DELHI, Sept 14 (PTI)

THE Supreme Court on Tuesday said it
would not reopen its decision on granting
reservation in promotions to Scheduled
Castes (SCs) and Scheduled Tribes (STs) as
it was for the States to decide how they
implement it. Taking up various pleas per-
taining to alleged hurdles in granting reser-
vation in promotions to SCs and STs in var-
ious States, a three-judge bench headed by
Justice Nageswara Rao directed the
Advocate on Records of State Governments
to identify issues peculiar to them and sub-
mit those within two weeks.

"We are making it very clear that we
are not going to reopen Nagraj or Jarnail Singh
(cases) because the idea was only to decide
these cases in accordance with the law laid
down by the court," said the bench, also
comprising Justices Sanjiv Khanna and B
R Gavai. The top court noted that in its ear-
lier order, the State Governments were
directed to finalise the issues which are
peculiar to them so that court can proceed
in the matter.

Manoj Raut on Tuesday said 261
ZP teachers and scores of vil-
lagers went about convincing
people about the cause and the

"They visited each village in the

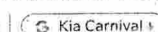
