हक ने कहा कि संरा प्रमुख ने भारत और पाकिस्तान दोनों से अनुरोध किया है कि वे 'स्थित को बातचीत से सुलझाएं और जैसा कि हमने स्पष्ट किया है और खास तौर पर

मानवाधिकारों के लिए उच्चायुक्त के तौर पर साफ किया है कि कश्मीर की स्थिति का समाधान मानवाधिकार के पूर्ण सम्मान के साथ किया जा सकता है।' जम्मू कश्मीर का विशेष दर्जा खत्म किए जाने के बाद से भारत और पाकिस्तान के बीच तनाव बढ़ गया था। पाकिस्तान इस मामले को अंतरराष्ट्रीय

ांच पर उठाने की कोशिश करता रहा है लेकिन भारत ने अनुच्छेद 370 के प्रावधानों को रद किए जाने के फैसले को अपना 'आंतरिक मामला' करार दिया है। देश के पहले गृह मंत्री सरदार बल्लभभाई पटेल की जयंती पर दोनों केंद्र शासित प्रदेश अस्तित्व में आए।
