The 7th Annual General Meeting of the members of the JIGAR CABLES LIMITED was convened at 11:00 A.M. on Friday, September 29, 2023 at the registered office of the company situated at Plot No. 164/14 & 15, Jamwadi, G.I.D.C., Gondal, Dist: Rajkot – 360 311, Gujarat (India).

Mrs. Sangitaben N. Vaghasiya, Chairperson and Managing Director of the Company chaired the meeting.

CS Priyanka Marvania, Company Secretary welcomed the Directors and Chief Financial Officer present at the meeting. Mr. Rushabh R Shah from M/s. Rushabh R Shah and CO., Statutory Auditors and CS Piyush Jethva, Secretarial Auditor of the Company were also present at the meeting. The voting rights of the members was In proportion to their shares in the paid up equity share capital of the Company as on cut-off date September 22, 2023.

CS Piyush Jethva, Practising Company Secretary was the Scrutinizer appointed by the Board to scrutinize the entire voting process in a fair and transparent manner.
