PNC CONTINUES GROWTH IN Q1

Prithish Nandy Communications announced its Q1 result after its last board meeting.

The Q1 results show revenue of Rs 1282.38 lakh compared to last year's Q1 of Rs 96.85 lakh resulting in a 1224% growth in revenue. Loss in Q1 is Rs 77.45 lakh as against the loss of Rs 69.70 lakh in last year's Q1.

The Mumbai chapter of the international show *Modern Love*, produced by PNC in association with Amazon Prime Video and the New York Times, was globally premiered on May 13 across 240 nations and territories.
